## Re Bank Notes.

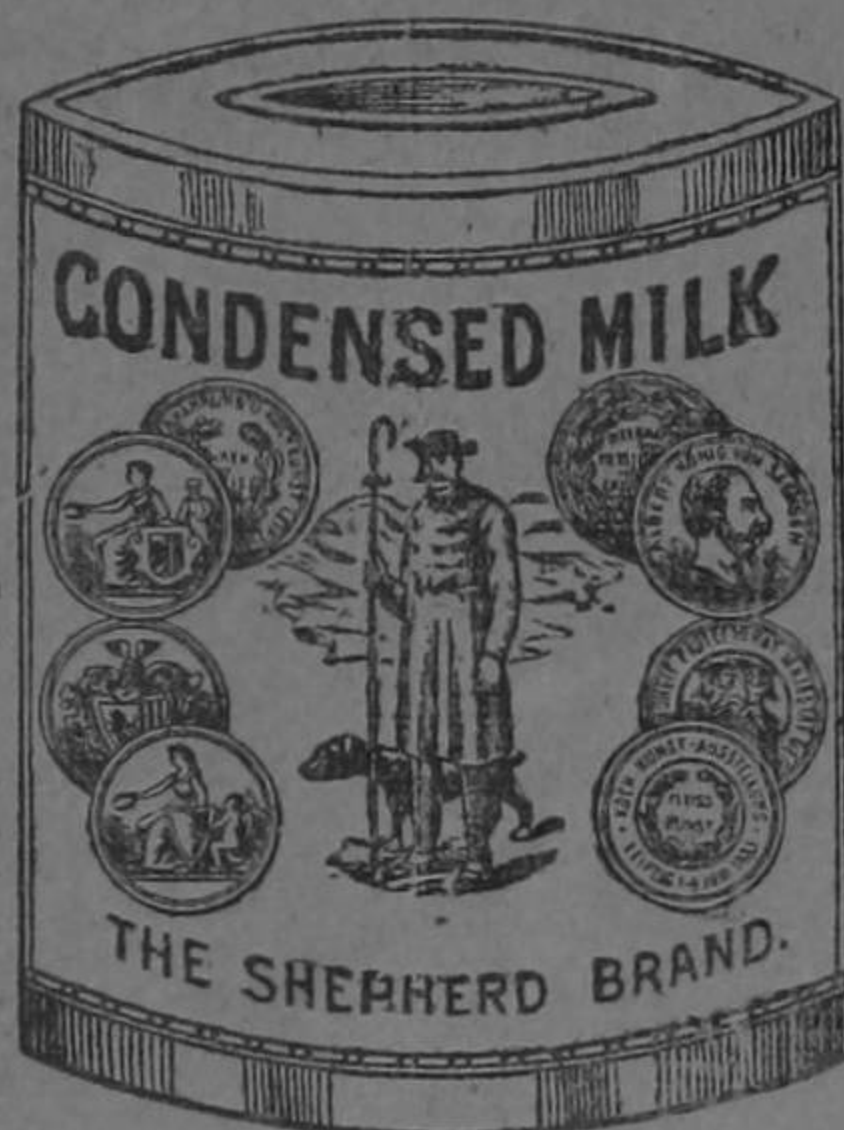

### SUPPORT BOTH COMPANIES.

It is indeed an ill wind that blows no one good. After hearing so many different opinions on the matter of the lawsuit established and the expected banana war, it gives one the idea of an opinion too, in the columns of this journal there have been many letters, some for the United Fruit Company and others for the Atlantic, but if there is anything that we may be pleased at, it is to find that the suggestions thrown out by this Journal with regard to giving the small man a fair chance at some of the lands that have been run to wreck by the inexperienced mandadors. We learn on very good authority that the officers of the U. F. Company intend giving out the lands that the mandadors cannot handle, to the industrious honest man and afford him such aid by way of animals and cash to help him to handle the soil that will result in the mutual benefits to himself and company alike.

We learn that all along the lines at Guacimo and the different sections where Mr. Reid on behalf of the company formerly refused to allow the small settlers to plant bananas on the company's lands, on the plea that they would not work for the company if allowed to cultivate for themselves, the officers of the company are offering all inducements to these very people to take up all the available lands and cultivate them and sell the fruit to the U. F. Company. How surprised we are to find that this company did not find out that it was more profitable for them to buy bananas than to cultivate them under their methods, until the advent of the Atlantic Fruit and Steamship Company, therefore their presence has done us some good even if it is for a month, but it shall have brought out a certain amount of opportunities for us, that we might never have seen. We are not mindful of the benefits we have derived from the U. F. Company but there are lots of room for betterments. When we come to consider the price that bananas are sold at in foreign markets and the price paid here for them we feel it would not be out of place that the company could pay 50 cents per bunch instead of 30 and allow the grower 8 eight hands for two firsts, for we are in a position to assert that away from the unforeseen, a cargo of fruit distributed in the States does not cost anywhere beyond seventy cents, why could we not get 20 cents more. But this we can never expect so long as any one company operates here. Those who may have retained a copy of Don Ricardo Jimenez's speech at Arrasty's during the election may bear me out. If two companies come in the field we have little or no necessity for contracts, all

we want is an understanding who will give us the best prices for our fruit. It astonishes us therefore to find that so many of the people who will be benefitted by the presence of another company are taking the sword of one against the other. Let both companies alone to settle their dispute, but we as spectators have no right to interfere by depreciating the qualities of one for the other, all we want to see is the fight settled by them and a prosperous fruit industry opened up in the country.

## Banana Fight in Santa Marta.

About six weeks ago the Atlantic Fruit Co. acquired large plantations in Santa Marta, Colombia. A short time after in making their first shipment of fruit the United Fruit Co. filed an action against the Atlantic for conspiring with the planters in order to defraud them and place an embargo on the cargo of fruit in order to prevent the Atlantic from shipping bananas.

Mr. Schimernorn and Sr. Quintero left here hurriedly on a special steamer for the scene of action. Within the past few days a rumor has been current that the Atlantic had been victorious and that the producers had gone over to them; with a view of getting some authentic information on this very important and interesting competition now going on in the sister Republic and as the indications here points to similar situation, we obtained an interview with the Representative of the Atlantic Fruit Co., Mr. R. C. Wetmore with the object of making our selves fully acquainted with the facts of the case. Mr. Wetmore assured us that the operations of the Atlantic Company in Santa Marta as was anticipated, has been of a most successful nature and had the entire support of the planters; that the shipments show an increase of forty per cent weekly, further that a cable has been received here yesterday which states that the U. F. Company tried to embargo the cargo in Santa Marta but they lost the suit. They then tried to do the same in the United States but the Judge decided against them there also. We were assured by Mr. Wetmore that he would very shortly commence operations here and that the indications pointed to as successful an issue here as in Santa Marta.

## Brighter Hopes.

We learn on very good authority that there is a gentleman who has recently arrive in the country whose mission it is to see the possibility for taking fruit to European markets, possibly Spain.

This gentleman arrived by the Spanish boat here and is interested in that line of boats by way of seeking closer connections with the mother country and banana is one line of trade that he intends to grasp at, and we would not be surprised to find that some of the new large banana farms that are being made, by native capital will be turned over to this purpose, therefore it seems as if instead of having two companies we may possibly have there or four but of a certain if it is even take what fruits may be specially planted for these people along, these people intend to cater for fruit for these boats by way of freight.

## Observation along the Lines

The Banana war is proceeding hotly, the agents of the U. F. Coy. are running up and down along the lines compelling the people to sign contracts of all sorts some in Blank other Spanish without any interpreters, even the Supl. do not know enough Spanish to explain to the people the terms of the Contracts hence these contracts are illegal as the law demands an official interpreter to explain to the man what he is signing it. Mr. Blackwell at 16 miles informs us that Mr. Veitch handed him a blank form without a word of either English or Spanish to sign as a contract, he signed his name to a blank and God knows what may be filled up afterwards; and others around there have done likewise.

The Roadmaster of the railway has commissioned his gangs to prevent people from doing traffic on the Railroad, but in the interests of the U. F. Company.

The people who intend giving fruit to the Atlantic have to keep it away in the bush off the track. The Agents of the Atlantic come along and pay for all this fruit so delivered. Along the lines to Siquirres and onward the competition is as keen.

The Whilhelmina arrived from Bluefields to take fruit from Cahuita and Old Harbour to Limon. The feelings of the people are for the Atlantic and will give all moral support to her even those who are tied by contracts with whom we have spoken are determined to help the Atlantic meantime the officers of the U. F. Coy. are determined to use every effort "Regardless of consequences" to prevent the Atlantic shipping fruit this week and forever.

## Parches .....

En «El Noticiero» del 12 de junio, en una crónica de Limón firmada por el Corresponsal *Sereno*, (PARCHES DE LIMÓN) se dice que los guardas del muelle prohiben la entrada después de las seis de la tarde, a los pasajeros y a los marinos de los vapores anclados en el puerto. El corresponsal, en forma bastante ingeniosa, deja ver al través de los velos de sus frases, un juego entre los altos empleados de la Aduana y los guardas del muelle, que a ser cierto, deja ver muy poca seriedad.

La Prensa, ese cuarto poder que al correr de los tiempos va siendo una quimera en los países pequeños, donde los que con la autonomía que les otorgan los altos puestos que ocupan, solo tienen por norma absoluta su propio criterio, la Prensa, decimos, marcó muchas veces los defectos de esta clase de medidas, que no reportan provecho alguno, pero su voz, como todo lo que pasa, se perdió en el olvido, esfumándose en las regiones olímpicas de los cielos oficiales.

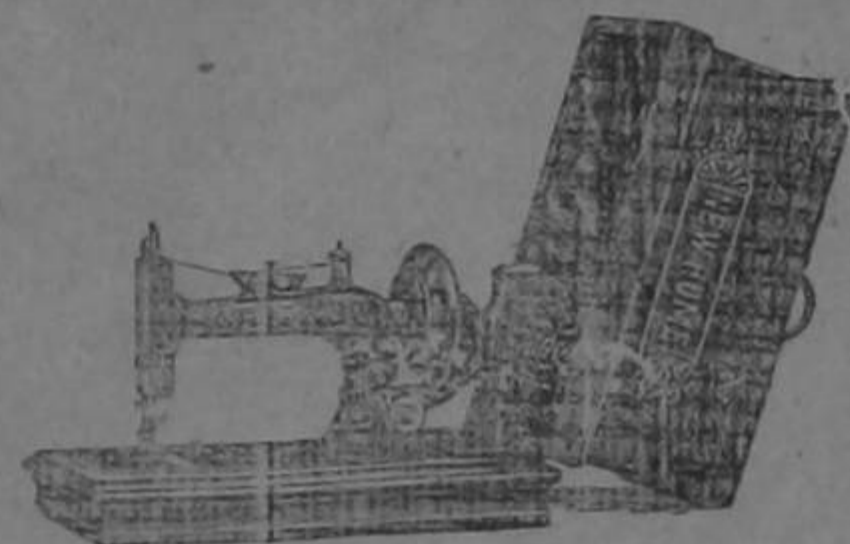

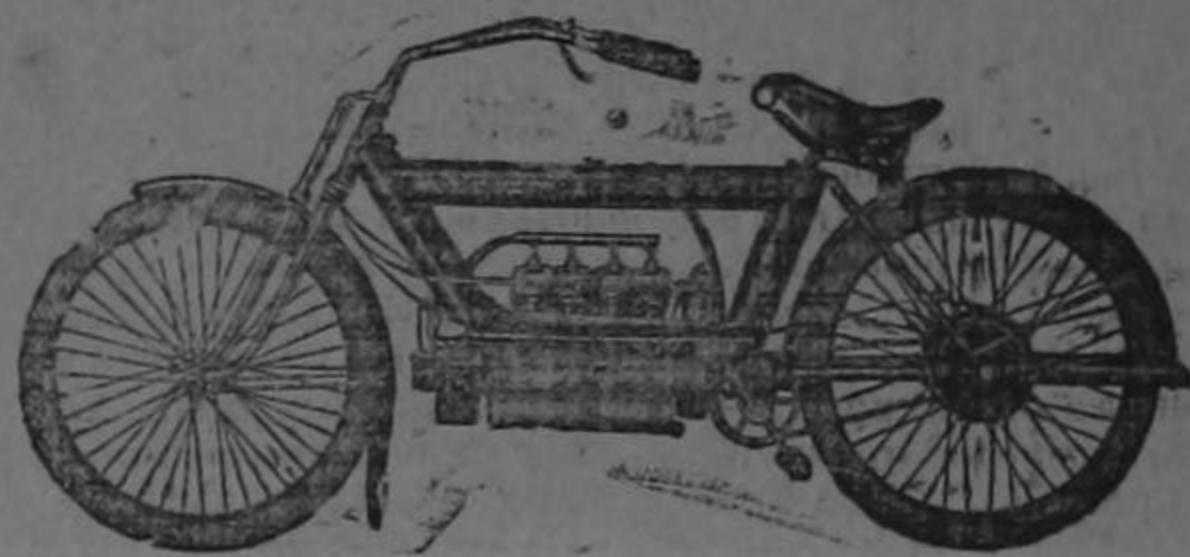
