Protesta contra las Compañías de Esso Gas

Por consumidores de Gas de la Ciudad de Limón

El pasado 22 de abril próximo pasado, se reunieron todos los consumidores de gas de la ciudad de Limón en los salones del Club Miramar, para abordar el gravísimo problema creado por el sorpresivo aumento del precio de ese combustible, considerado de vital importancia. En la reunión se acordó protestar públicamente ante el Departamento Comercial del Ministerio de Economía y a la propia Compañía, por ese aumento que los consumidores consideran injustificado e imposible de soportar.

Alegan, esos señores que la Compañía de Gas los engañó, porque cuando compraron sus cocinas se les prometió bajar el precio del gas conforme aumentaran los consumidores y ha sido lo contrario; constantemente han venido operándose aumentos, al extremo de que siendo últimamente el precio de \$ 50,00 cada cilindro, lo subieron a \$ 65,00 sin dar ninguna razón y con el agravante de ser autorizado por el Departamento Comercial del Ministerio de Economía. En la reunión se apreció de tal magnitud el problema que están dispuestos los poseedores de cocinas de gas a abandonarlas si el Gobierno no les brinda la protección, o la Compañía no escucha sus clamores.

No debe olvidarse de que en estos momentos en que el país hay escasez de energía eléctrica, el Estado está obligado a facilitar el consumo de otras clases de combustibles, así como lo ha hecho el Banco Central al clasificar el cañín en la categoría preferencial.

OUR TASK FROM OUR DESK BY THE EDITOR

Today we use these principal columns in tribute and to say "Adieu until we meet again" to Reverend and Mrs. William L. Ziadie who left our port on Monday night the 17th instant to spend several months well earned vacation in the great North American Republic.

About three years ago the British Diocese of Honduras transferred to The Canal Zone Diocese under the See of the Right Reverend R. Heber Goonen, S. T. D., among others, the Anglican Churches of Costa Rica.

The scene was changed: Out of the transfer a new day dawned; that when the Reverend & Mrs. William L. Ziadie arrived as Rector for the Parish of St. Mark's. There is a verse of Hebrew which is applicable to them:

"The wilderness and the solitary place shall be glad for them; and the desert shall rejoice and blossom as a rose."

So it turned out by their coming; they brought the olive branch; it was planted and spiritually watered during their sojourn in this city. It need a more worthy memory to remunerate the marvellous accomplishment evidenced. We cannot characterize by a dash of the pen the good humanitarian deeds done by Reverend Fr. Ziadie. He has not only ministered to feed the souls of mankind, but he endeavored to improve the general living conditions of those under his charge—charity for him seemingly had no bounds. We have testimonies of his services as a ministering angel to the sick of his Parish, at home or hospital; and not only to his own flock has he helped, but in a general way. By his progressive will now stands on the church yard a beautiful and modern Rectory.

We view with a sense of deep thought his purposes to give more Christian light to his members as well as to the general public in having His Lordship, the Bishop, Dean Ferris, the Reverends Fish and Turner come to Limon a few months ago and Ordained the Reverend William Graham Love to the sacred order of Priests. We believe the Ordination could have been administered at Ancon, Canal Zone, but thoughtfully desired to give us this grace, the Reverend William L. Ziadie had the service performed in Limon; so marvellous a part of Christianity in the march of civilization.

Mrs. Ziadie proves in all capacities as a talented musician. The touch of her fingers on the piano keys as we have seen on many public occasions cannot be easily erased from memory of those who comprehend and appreciate.

We pray that God will take the helm of the ship and steer safely them to the port of their destination. May they enjoy a rich hearty period of rest and recreation and return safely to Limon to resume the excellent work they started about three years ago.

By the Official Gazette of last Saturday we glean that the Chief Magistrate has granted permission to the Educational Committee of the General Tomas Guardia School in this city to hold three «TURNOS» during the year in course. We hope to be in a position in the very near future to announce the dates on which the fairs will be held.

First United States International Trade Fair

Chicago - August 7-19, 1950

Chicago, March 15. - New peak of activity was reached today by the First United States International Trade Fair which will be held in Chicago next August 7 to 20, 1950, as reservations for space rushed in from Europe and the United States.

From Paris, reservation for 464 booths was cabled to accommodate ten leading nations of the Marshall Plan group on the Navy Pier, where consumer goods will be located. Reservations for space in the International Amphitheatre, Coliseum and Arena, where industrial goods and raw ores and mineral are scheduled for exhibition are expected to follow shortly.

In the United States, the National Cash Register Co. reserved 1,000 square feet of space, one of the largest spaces thus far reserved by a single American firm.

From Athens, C. I. Terrell, Foreign Trade Administrator of the Ministry of National Economy, wired reservation for the Panhellenic Exporters Association.

Egypt reserved 1,000 square feet to accommodate its merchants and manufacturers. Reservation for Egypt was received from Ibrahim E. Imam, Commercial Secretary of the Royal Egyptian Embassy in Washington.

Reservation from Paris covered only the first allocation for consumer goods, totaling a minimum of 46,400 square feet.

The largest single group of goods for which 122 booths were set aside will cover apparel and accessories and jewelry and gift items.

Next largest grouping for which 101 booths have been allocated, will exhibit foods. These will include meat and dairy products, including cheese; canned, preserved, frozen and dehydrated fruits and vegetables and sea foods; confectionery products; beverages, both alcoholic and non-alcoholic, and miscellaneous food preparations.

Textiles, fabrics and yarns, for draperies, upholstery and wearing apparel will be accommodated in 70 booths.

Other groups according to quantity of booths reserved in the first allocation are: recreational equipment and toys, 54 booths; cosmetics, toiletries and drugs, 43 booths; home furnishings items, 34 booths; hardware and kitchen appliances, 19 booths; and retail store and office supplies and equipment, 21 booths.

Goods from more than forty nations will be on exhibit when the fair opens next August. Firms in more than twenty-eight different nations have already reserved space to exhibit before the thousands of buyers from the United States and other nations who are expected to attend, according to I. S. Anoff, president of the First United States International Trade Fair.

Stalin's "Separate Peace" in 1943

— By Dr. Robert M. W. Kempner —

Former Chief Prosecutor, Nuremberg War Crimes Trials

When Stalin negotiated with the Western Allies in 1943 and made his farreaching political and economic demands, he held as a trump card German offers for a separate peace with the Soviet Union. The Soviet dictator played his cards close, and just how prominently the plans for such a separate peace figured in the power politics of World War II, can only be judged by the success he enjoyed at the conference table.

In the course of my works in Nuremberg as chief prosecutor of Nazi diplomats and cabinet members, I discovered the various moves for a separate peace from a number of German and Allied diplomats and I checked their statements against official documents.

There is conclusive evidence that there were four major moves for a separate understanding with Russia: first, after the American landing in Africa at the end of 1942; second, at the beginning of the Anglo-American offensive against Tunisia in the spring of 1943; third, through Japan; and fourth, through Stockholm up to the fall of 1943. Conciliatory efforts reached

their climax in the summer of 1943 after which Russia made agreement conditional on such difficult terms that the Germans, while continuing to sound out Eastern peace possibilities until the end of the war, no longer seriously hoped for a separate peace.

I. When, in the winter of 1942-1943, the German military operations in the East did not meet with the success anticipated by Hitler and his generals, and the landing of the American troops in North Africa threatened the European western and southern fronts, leading German policy makers began for the first time to entertain the thought of a separate peace with the Soviet Union. Foreign Minister Joachim von Ribbentrop was the strongest exponent of this idea.

In November 1942 Ribbentrop drew up his plan for separate peace in the East in the form of a short memorandum to Hitler. The latter had scheduled a meeting with France's Premier Pierre Laval to confer on the new difficulties facing «Fortress Europe». Ribbentrop intercepted the Fuehrer as he

was in route to his meeting, and tried to present his plan. He boarded Hitler's special train at Bemberg, but met with rebuff. Hitler was so absorbed in considerations of how to treat the African landing in his forthcoming Munich talk with Laval that he curtly admonished his Foreign Minister to concentrate on the matter at hand.

II. Nevertheless, Ribbentrop continued to hammer at the idea that through a special peace with Russia he could force the United States and Great Britain also to seek peace with Germany. He submitted to Hitler during the years 1943 and 1944 a series of elaborate memoranda on the importance of a separate peace with Russia.

Ribbentrop found support for his plans in the reports of the German Ambassador in Rome, Hans Georg von Mackense. The Ambassador relayed repeated peace with Russia. Mussolini urged the same thing in a letter to Hitler on March 25, 1943, and shortly thereafter, emphasized it personally, when he met with Hitler from April 6 to 10 at Castle Klessheim near Salzburg, Austria. GIGANTIC TASK AHEAD

The world economic picture that faced the ECOSOC delegated divided into two main themes: (1) how to maintain employment and avert economic slumps in the technically advanced countries; (2) how to use modern technology to increase manufactures and trade and improve agriculture in the backward countries, so that they may better provide for their populations.

The "boom and bust" cycle of the advanced nations was regarded as due to instability of private investment in plant, equipment, business inventories and residential building. (But it was foreseen that remedies must differ somewhat in different countries depending on the degree of governmental planning and control.

BRINGING UP THE COLONIES

Another "minor league" tussle that has been obscured by East-West strife centers in the Trusteeship Council, where the colonial and noncolonial powers have been slugging it out for some time. The Council is determined that the peoples of the trust areas and non-selfgoverning territories shall have a chance to "grow up" in the family of nations. They want them to advance socially and economically, and learn to manage their own affairs. The Council won a major victory when the Fourth General Assembly confirmed its right

to appraise and criticize the work of the administering governments.

One way of doing this is by on-the-spot inspection: As ordered by the Council's Sixth Session, which met recently in Geneva, Small groups of its members will leave promptly for the Pacific, to visit Nauru (see UNW, January), New Guinea, Western Samoa, and the islands of the Marianas, Carolines and Marshalls. They will look around and see for themselves whether the natives are getting a square deal, and what needs to be changed.

WHO: AFTER THE MAD DOGS

Egypt and Israel see eye-to-eye on one thing: their urgent desire to control

human rabies, resulting from the bite of a mad dog. Last month the World Health Organization's doctors and researchers began experiments in both countries with a new concentrated hyper-immune serum for human beings. It had been tried only on animals in the United States, but was found to give these a longer and higher immunity from rabies than the old vaccine, the effect of which lasted only for a year.

In Egypt, where the dog population is huge, mortality from human rabies is one of the highest in the world, despite vaccination. The new serum will be tried out there on some 400 persons in tests groups, over a period of a year and a half. In Israel it will be used experimentally for eradication of rabies by inoculation of dogs.
