II. Planes para la expansión:

En consecuencia, el Banco, aún cuando puede hacer préstamos que no podrían ser hechos por prestamistas privados, en condiciones razonables, tiene que conducir sus operaciones de manera que sean aceptables por los inversionistas particulares. Así pues, el Banco no puede hacer donaciones ni conceder créditos fáciles y debe

usar de prudencia y cuidado al conceder sus empréstitos.

Los propósitos y objetivos del Banco Mundial están claramente definidos en el Convenio y pueden resumirse aquí:

(1) Ayudaren la reconstrucción y desarrollo de los países miembros, mediante préstamos de capital para aumentar la producción y, por consecuencia, promover el crecimiento a largo plazo del comercio y ellevantamiento del nivel de vida.

(2) Promover la inversión de fondos privados mediante la garantía y participación en préstamos e inversiones de capitales particulares, y

(3) Hacer préstamos de sus propios fondos o de fondos prestados para propósitos productivos cuando no haya capital privado disponible en condiciones razonables.

EDITORIAL

A continuación de nuestro punto de vista en el mitin recientemente verificado para tratar el interés de la Industria de Banano, asunto que ha estado despertando mucha atención, repetimos que, los productores pueden tener a su comando el arma para pelear todas sus batallas, si ellos deciden retirarse del camino de industrialismo y organizarse. Existe la necesidad de voces selectas para hablar por todos; y existe la necesidad de una pluma designada para escribir por todos.

Por medio de locales bien establecidos los problemas difíciles de cada zona serían notificados a una Oficina Central la cual se encargaría de poner remedio a la situación. Con esfuerzos organizados, las dificultades, por ejemplo de tener desreglos con los bananos destinados a las plataformas de compra como un resultado del sistema de transporte particular, puede ser remediado.

No tenemos duda de la posibilidad de obtener precios elevados para los productores si nuevos exportadores ingresan en el mercado, pero un estudio muy detenido es necesario en muchas fases.

Nuestros agricultores, creemos, no deberían cerrar sus ojos al hecho de que la producción no está todavía a nuestro alcance para poder suplir a un gran número de exportadores.

En otro punto de vista las altas tarifas de ferrocarril por el acarreo de los bananos a nuestros muelles demandan un gasto muy significativo para el exportador, pudiéndose llegar al caso en que se alquila cierta cantidad necesitada; teniendo el exportador que pagar siempre a la Compañía por la alquilada. Además las lanchas que esperan por un cargamento total y no se logra conseguir tal cargamento siempre tiene que pagarse el costo del contrato. Algunas condiciones como las citadas anteriormente resultarían en el abandono o el retiro de las compañías exportadoras de la zona Atlántica. Si algunos de los exportadores quedarán naturalmente vendrían a ser monarcas en el asunto.

Las zonas libres a cualquier comprador solamente pueden ser establecidas satisfactoriamente si el señor Ministro de Agricultura e Industrias solicite la apertura de un departamento de crédito agrícola rural por medio del Banco Nacional; indicando así que los productores puedan obtener préstamos con intereses moderados y planes fáciles de pago.

Entendemos que el precio por racimo es tres cincuenta esta semana debido al rebajo del precio en el mercado extranjero. Esto es sin duda lamentable; pero igual es el resultado de las ganancias y pérdidas en el comercio.

El resultado fué el Banco Mundial.

OUR TASK FROM OUR DESK

BY THE EDITOR

In continuation of our views on the recently held meeting in the interest of our Banana Industry; a matter which has been drawing much attention, we repeat that the producers can have at their command the weapon to fight their battle, if they would step out the path of individualism and be organized. There is need for voices chosen to speak for all; there is need for a pen chosen to write for all. By well established locals the difficult problems of each zone would be made known to a Central Body which in turn would try to effect the remedy. Strike a singly match against the wind and no light will appear, but against the fury of the wind from a bundle of matches light will flash. With organized efforts, the ills, for instance, of having disarrangements with fruits destined for buying platforms as the result of privately owned transport systems, can be cured.

We are not in doubt as to the possibility of higher prices obtainable by the producers if new exporters enter the market, but deep study is necessary in many phases. Our farmers, we believe, should not close their eyes to the fact that production is not yet within reach to supply a rush of exporters. On the other hand the high railroad rates for hauling the bananas to our docks and what would it mean but the killing of the goose which laid the golden egg, to hire trains to loading platforms intended to obtain a given number of stems and have to face the disappointment by receiving a few hundred bunches and with boats engaged for a complete shipment. A few such blows to the buying companies and all would bid adieu to the Atlantic. If any weathers the storm, quite naturally, such would become monarch of all he surveys.

The free zones to any buyer can only be established successfully if the Minister of Agriculture and Industries would move for the opening of Rural Agricultural Credit Department in the Limon Branch of the National Bank by which means the producers, when their financial tide is low could obtain loans with moderate interest and easy payment plans.


The Lottery Administration will sell the series of ten tickets for ₡ 112.50 instead of the present cost of ₡ 105.00.

Universal Declaration of Human Rights

- Continued from the issue of April 1st -

Article 25:-I: Every one has the right to a standard of living adequate for the health and well-being of himself and of his family, including food, clothing, housing and medical care and necessary social services, and the right to security in the event of unemployment, sickness, disability, widowhood, old age or other lack of livelihood in circumstances beyond his control.

2. Motherhood and childhood are entitled to special care and assistance. All children, whether born in or out of wedlock, shall enjoy the same social protection.

Article 26:-I: Everyone has the right to education. Education shall be free, at least in the elementary and fundamental stages. Elementary education shall be compulsory. Technical and professional education shall be made generally available and higher education shall be equally accessible to all on the basis of merit.

Education shall be directed to the full development of the human personality and to the strengthening of respect for human rights and fundamental freedoms. It shall promote understanding, tolerance and friendship among all nations, racial or religious groups, and shall further the activities of the United Nations for the maintenance of peace.

3. Parents have the prior right to choose the kind of education that shall be given to their children.

Article 27:-I: Everyone has the right freely to participate in the cultural life of the community, to enjoy the arts and to share in scientific advancement and its benefits.

2. Everyone has the right to the protection of the moral and material interests resulting from any scientific, literary or artistic production of which he is the author.

Article 28:- Everyone is entitled to a social and international order in which the rights and freedoms set forth in this Declaration can be fully realized.

Article 29:-I: Everyone has duties to the community in which alone the free and full development of his personality is possible.

In the exercise of his rights and freedoms, everyone shall be subject only to such limitations as are determined by law solely for the purpose of securing due recognition and respect for the rights and freedoms of others and of meeting the just requirements of morality, public order and the general welfare in a democratic society.

3. These rights and freedoms may in no case be exercised contrary to the purposes and principles of the United Nations.

Article 30:- Nothing in this Declaration may be interpreted as implying for any State, group or person and right to engage in any activity or to perform any act aimed at the destruction of any of the rights and freedom set forth herein.
