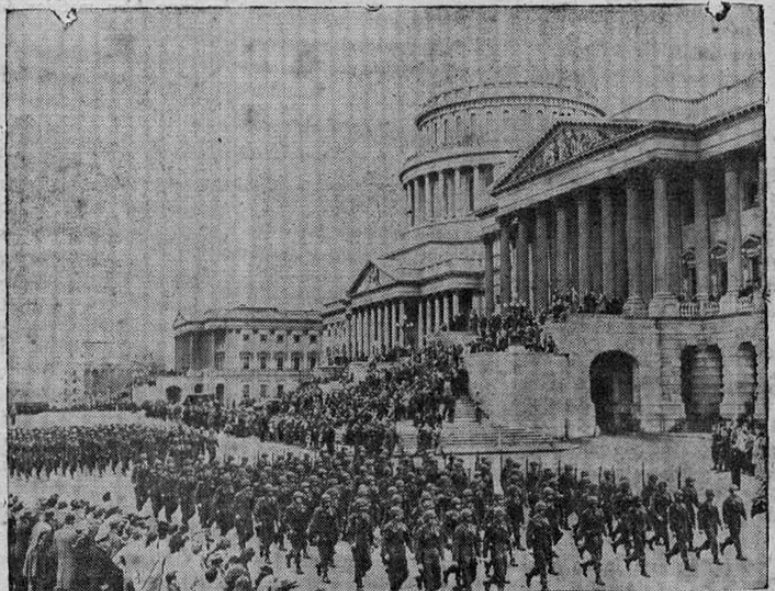

La Política de Paz de los EE. UU. Tendrá el Apoyo Unánime de Todos los Partidos

WASHINGTON.—De las incertidumbres y obstáculos que dificultaron los esfuerzos de las cuatro potencias principales para establecer la concordia universal, ha ido materializando en los Estados Unidos una política exterior constructiva y positiva destinada a realizar la paz entre los pueblos, que tendrá asegurado el firme apoyo de ambos partidos políticos, según ha declarado hace poco el Senador Arthur H. Vandenberg de Michigan, destacada figura entre los representantes republicanos en el Congreso.

En su informe al Senado acerca de la reunión de Ministros de Relaciones Exteriores celebrada en París, a la que asistió en calidad de consejero del Secretario de Estado James F. Byrnes, el senador Vandenberg manifestó que la política exterior de los Estados Unidos, apoyada por los dos partidos políticos, se basa, a la vez, en los principios morales asentados en la Carta del Atlántico y en el Estatuto de las Naciones Unidas aprobado en San Francisco, y en las necesidades prácticas que son indispensables para la rehabilitación de Europa.

"Es ésta una política," continuó el señor Vandenberg, "que tiene por objeto terminar cuanto antes los regímenes inconclusos actuales derivados del armisticio, y que están postponiendo la paz más allá de los límites marcados por la razón y la seguridad. Es ésta, asimismo, una política que requiere prontitud en la formulación de tratados de paz no sólo con Italia, Rumania, Bulgaria, Hungría y Finlandia, sino también con Austria que está muy al centro del problema total del continente."

"Es ésta una política que requiere prontitud en las decisiones relativas a la unificación de Alemania, sitio donde reside el verdadero centro de la recuperación de Europa, y donde el problema debe considerarse en general más bien que como si estuviera dividido en cuatro her-

méticos compartimentos que corresponden a las cuatro zonas militares de ocupación.

"Es ésta una política que da garantías máximas de protección contra el resurgimiento de los agresores del Eje, y que dramáticamente ofrece determinadas garantías como prueba del sincero propósito de los Estados Unidos. Es ésta una política de desmilitarización. Es ésta una política que substituye con la justicia la venganza en estas fórmulas de paz; que ahora insiste en que no se establezcan diferencias étnicas, que no coartemos a pueblos indefensos, y que renuncia al expansionismo como grave amenaza a la paz y la seguridad del porvenir.

"Es ésta una política que invita a todos los países asociados en la guerra—en lugar de una acción limitada a cuatro potencias principales—para que tengan voz y voto en la formulación de los tratados y en el programa de la paz que resultó de las victorias que todos contribuimos a ganar. Es ésta, finalmente, una política que exige una paz dictada por los pueblos."

"A UN MIRON CIEGO"

NOTAS EDITORIALES

LA CARRETERA A SAN JOSE

El licenciado don Francisco Fonseca Chamier, Diputado por la Provincia de Limón y Presidente del Congreso, hizo en La Tribuna de la semana pasada interesantes declaraciones sobre la carretera de San José a Limón. Esta necesidad hondamente sentida por los habitantes de la provincia atlántica puede convertirse en realidad si aprovechamos el momento.

Efectivamente, como dice el Licenciado Fonseca Chamier, no es un trabajo de Hércules. Cien kilómetros de carretera que una a Limón primer puerto de Costa Rica en el Atlántico, con la costa del Pacífico y con la extensa ramificación de carreteras de la meseta central, no es una obra de beneficio exclusivo de la zona atlántica sino una obra nacional de incalculables beneficios para todo el país.

El costo de la obra alcanzará a unos cinco millones de colones. No hay que espantarse de esa cifra. El impuesto de un céntimo para las mercaderías importadas que corresponde a esta provincia, puede pagar la carretera en menos de veinte años.

Pero lo que interesa en el momento actual no es hacer divagaciones sino ejecutar hechos. Es necesario que la Corporación Municipal contrate los servicios de un ingeniero que conozca la zona para que haga un estudio del trazado y pueda saberse a ciencia cierta, su costo, su extensión y la importancia de las tierras que habilita.

Es necesario también conseguir del Congreso y del Poder Ejecutivo autorización para contratar un empréstito y autorización para que el Banco retire diariamente y lo abone al servicio del mismo, la suma que corresponda a la provincia de Limón por el recargo de un céntimo en las mercaderías importadas.

Es el momento en que todas las corporaciones, las compañías extranjeras y nacionales, el comercio, la agricultura y la industria de la provincia, apoyen la iniciativa del Licenciado Fonseca, no platónicamente haciendo comentarios de corrillo, sino con apoyo efectivo. No es momento de política sino de acción. Que sienta el Licenciado Fonseca Chamier que todas las fuerzas vivas de la zona, sin distinción de colores políticos o de ideologías. Sólo así llegaremos a ver la carretera. Sólo así despertaremos las enormes extensiones de tierras dormidas y acercaremos el latir de nuestra vida al corazón del país.

Jamaica is Favoured Again for the Recruitment of Farm Workers

It has been released that Jamaica is favoured again with a recruitment of workmen for Agricultural Work in the United States of America.

We quote below the text of the decisions which had been arrived at by the Jamaica Executive Council in conjunction with the recruitment:

The Labour Department should handle the recruitment of Farm Workers for the parish of Kingston, through the Kingston Employment Bureau.

In the other parishes members of the House of Representatives will recommend to the Labour Department persons in their Constituencies who should be Ticket Distributors.

50% of workers selected must be persons with previous experience in the U. S.

Provision will be made for Ex-Servicemen up to a total of 15%.

Consequent on these directions, the Labour Department has made the following arrangements:—

Members of the House of Representatives for parishes other than Kingston will send to the Labour Adviser a list of persons whom they appoint as Ticket Distributors.

The Labour Adviser will issue to each distributor a form of instructions setting

out the type of persons required by the United States authorities and a form on which he will list persons recommended by him as fit candidates for recruitment.

The Labour Adviser has received from the United States the names of former workers whose service or conduct have been such as to preclude them from further recruitment.

If the name of any such person appears on a Distributor's list it will be struck off, in accordance with instructions received.

When the time and place of recruitment is settled a Call Card will be sent to each worker by Registered Post, advising him of the centre at which he should attend. This card indicates that it is not transferable, and that impersonation is a criminal offence.

Workers in Kingston are informed that no registration of applicants for Farm Work will be made at the Kingston Employment Bureau and that further information with regard to recruitment in Kingston will be published later.

Recommendations for recruitment of Ex-Servicemen as Farm Workers will be made through the Re-absorption Officer in Kingston and the Parish Committees for Ex-Service Personnel in country parishes.

Methods of teaching change almost as rapidly, these days, as feminine fashions; delegates to conferences which are held at fairly regular intervals to investigate educational matters, make their recommendations and as a result the school curriculum is subject to various alterations and revisions.

Handworn, for example, is assuming a more and more important place in schools; educationalists realise that an occupation which engages the child's hands as well as its mind, is bound to leave a more lasting impression than a subject which is taught only by aural means.

Picture puzzles are finding more and more enthusiastic champions; map puzzles, Bible puzzles and puzzles of a general or topical interest can now be obtained for educational purposes, and it is claimed for the maps, for example, that when once the child has made up one of these puzzles, the subject will

be so clearly impressed on the mind that the positions of the various counties, towns, and coastline will immediately come to mind when reference is again made to that country.

The puzzles consist of an envelope, on the face of which is a miniature reproduction, in full colour, of the finished picture, and the contents of the envelope are a key-card, which is a thin cardboard sheet on which is printed a black outline of the subject, and a sheet of gummed paper on which the various puzzle pieces are printed.

The process of making up the puzzle takes anything from one to two and a half hours, according to the age of the child. The child cuts out the puzzle pieces and places them in their correct positions on the key-card, but does not stick them down until all the pieces are ready and have been placed in their correct positions; the child then proceeds to moisten the pieces

and stick them down, finally producing a complete and highly attractive picture.

The range of puzzles in this series is now a very wide one, and in addition to teaching Scripture with the Bible Picture Puzzles, it is possible to obtain Historical Picture Puzzles, illustrating familiar scenes from mediaeval and modern English history, such as the Princes in the Tower, Victoria Learns of Her Succession to the Throne, etc.; of railway engines and aeroplanes; for teaching the combination and history of the English flag there is a Union Jack Puzzle.

Not the least important reason for the popularity of these puzzles is their price; the Biblical, Historical and General Children's subjects cost a penny each, while the larger double-sized puzzles cost twopenny, and are obtainable from practically all stationers' shops.

United States Naval Secret Weapon Deadlier than Atom Bomb:

WASHINGTON, May 23. The United States navy has perfected a supersecret weapon far more terrible than the atomic bomb and has it ready for instant use, Rep. Albert Thomas, Texas Democrat told the house today.

Thomas, a member of the appropriations naval sub-committee blurred out this startling information during a hot floor battle between big Navy advocates and an economy bloc that is trying to slash \$ 1,700,000,000 dollars from the Navy's 1947 budget. The texan, who is backing the economy bloc, leaped up to challenge the contention that a cut in naval appropriations would imperil the national security.

"We have something far more deadly than the atomic bomb today — not tomorrow," he said. "And furthermore, it's in usable shape".

Thomas stopped short; and did not elaborate on his remark.

When newsmen pressed him for more details, he said he was "afraid" he already talked too much. He declined all further information, except that the secret weapon was developed in the Navy's bureau of medicine and surgery.

That stirred speculation about everything from bacteriological warfare to a "death ray".

Representative Harry Sheppard, California Democrat, chairman of the appropriations sub-committee, supported "Thomas" statement about the existence of a new weapon.

ENVIABLE POSITION

"This nation is in possession of scientific factors which places it in an enviable position," he told reporters. "The scientific factors at hand would result in devastation equal to, if not greater than the atomic bomb".

ed to give any more information.

"Remember", he cautioned newsmen, "there are different kinds of devastation".

Ask when he thought an official disclosure on the weapon might be made, he replied: "May be never".

He added that Navy Surgeon General Ross McIntire contributed to its development but that the project was not an all-Navy affair. He said it was developed by "a combination of interests".

The Navy bill debate also produced a demand by two Republican representatives for a congressional investigation of the War Shipping Administration.

Last Saturday evening effecting our distribution around this city, we observed the rising of the beautiful new moon of late Spring. After an hour's time we had circled the city and returned in front of the Post Office; again we lifted our eyes to bless them with this very strange and impressive work of Nature and within a

few moments of gazing we beheld the star actually fell on the moon in our describable way as a fallen stone on one's head; the scene was changed to a completely darkened moon. The number of gazers increased, including our esteemed Postmaster, Don Fermín Blanco and other employees of the Post Office.

As we watched, gradually the darkness in form of a veil began to be lifted from the lower part of the moon and her brilliancy reappeared by degrees; the final outcome of the star rests with Nature's God, the creator and ruler of the planets and all things.

**FEAT OF EMPIRE FLYING - BOATS
20,000,000 miles in the air**

The Short Empire flying-boats of the British Overseas Airways Corporation have just completed twenty million miles in the air. In 1934, Imperial Airways placed an order with Short Brothers (Rochester and Bedford), Limited, for two flying-boats to replace the obsolescent boats which had been working between Brindisi and Alexandria. The original intention was to test the design under practical service conditions before proceeding with a large order. In 1935, however, with the development of the Empire Air Scheme, a large new fleet became an immediate necessity. With Air Ministry consent, Imperial Airways ordered 28 flying-boats off the drawing board, thus backing its faith in British design to the amount of £ 1,750,000, the estimated cost of the fleet.

This faith was justified, and by the end of 1936 four of the new flying-boats were in commission. In succeeding years others came off the production line until I. A. had taken delivery of 39 aircraft, all of them approximately similar in design, but incorporating in some cases Bristol Pegasus engines of higher power than those installed in the original S. 23 machines. Before the war the boats carried the main burden of the mail and passenger services on the chief Empire routes via India to Australia, and to South Africa. In December, 1937, Centaurus made a combined survey and goodwill flight from England to New Zealand via Australia, thus accomplishing the first crossing of the Tasman Sea by a commercial flying-boat. And in the same year Caledonia and Cambria, which had been modified for Atlantic work, began experimental flights to Montreal and New York via Foynes (Eire) and Botwood,

Transatlantic Operation

In 1939 a transatlantic mail service was begun by Cabot and Caribou, which were refuelled while in flight. Fifty thousand miles of flying were completed by these two boats until, at the outbreak of the war, they were required for service with the RAF. A further development in 1939 was the delivery by Short Bro-

thers of the three G class boats, which were enlarged versions of the Empire boat for operation across the Atlantic. They, too, were taken over by the RAF. Both Cabot and Caribou, with crews mostly recruited from B. O. A. C. were lost during the Norwegian campaign. Cambria and Coorong were used in the evacuation of Crete in 1941, when, flying unarmored and for the most part unescorted, these aircraft brought 460 passengers from the besieged island.

When the Japanese entered the war in 1941, the flying-boats undertook similar work in the Far East; where they were flown mainly by crews of Qantas Empire Airways, the Australian associate of B. O. A. C. In December, 1941, Cassiopaea was lost during the operation at Sabang, Dutch East Indies, and in January, 1942, Corio was attacked off Koipang, Timor, by a formation of Japanese fighters. Its commander, Captain Koch, took strenuous evasive action, but in spite of his efforts the aircraft was forced down into the sea. Some survivors, including Captain Koch, swam ashore.

On the evening of February 3rd, 1942, Captain W. H. Crowther brought the last Empire flying-boat into Singapore. He took off early next

morning in bright moonlight with no flarepath and carrying forty passengers; shortly afterwards the Japanese landed on the Island, cutting the route to Australia. After the break in this route 6 flying boats operating to the Eastwards of the fracture were used for carrying supplies under reinforcements to the Dutch East Indies and for the evacuation of the thousands of refugees, mostly women and children. Circe and Corina were lost during these operations, together with Centaurus and Calypso, which were flying with the R. A. F.

West of the break the Empire boats were used to maintain vital connections and the so called "Horseshoe" route from Calcutta across India and via Egypt to Durban, South Africa. This route connected with another across Africa to Lagos, Ngeria and the United Kingdom, thus avoiding the battle areas of the Mediterranean. One particularly interesting achievement was the series of transatlantic flights by the modified boats Clair and Clyde, in the summer of 1940, when the battle of Britain was raging. Not only have the Empire boats had a profound influence upon the development of British Civil Aviation but they were also the basis of the design of the Short Sunderland military flying-boat, which gave such remarkable war service.

**LINKING COSTA RICA AND PANAMA
IN THE SOUTH BY RAILROAD**

We learn that a project has been launched to link the southern part of this Republic to Panama by the construction of a railroad to connect with that of Panama. The Costa Rica Banana Company in its ever increasing progressive programme and deep seated interest in the agricultural development of Costa Rica has already commenced the work and at the same time the Company is said to intensifying its banana cultivation in the Pacific regions.

We say "Thanks" to Mr. Hamer, the genial Manager and his associates.

This outstanding enthusiasm on the part of Don Alfonso has not taken us by surprise for he has from time to time effecting sincere and wise proposals in line of improvement for this zone. His vice presidency in a recently passed regime of the Municipal Council bears testimony of his foresightedness. Today, in common with his associates of the Social Protection Committee, Mr. Sole is forging rough metal into smooth and polished material to effect general improvement to the building of the United Medical and Sanitary Department; - a renovation to afford the establishing of a Maternity Ward and other necessary conveniences.

**AS AN INDIAN SEES IT
Peace Will Come Only When Man
Ceases to Exploit**

The Atomic Bomb has provoked a good deal of discussion, ranging all the way from the sensible to the fantastic. Most sensible has been the attitude of the scientists including those involved in developing it. These scientists are almost unanimously of the opinion that the knowledge of the process of releasing atomic energy should be shared with others, since the basic principles are fairly well known and the highly industrialized countries are bound to discover the process by themselves in the not too distant future. At the other extreme are those who believe that the United States, Great Britain and Canada should hang on to the secret and, by using it as a threat, bend others to their will, police the world and prevent another war.

LOGIC AND COMMON sense are, of course, on the side of the scientists. It is fantastic to imagine that a peaceful world can be created by threatening the violator with the atom bomb. Beyond doubt other countries will soon develop the atom bomb. As past history of warfare has shown, anti-atom bomb weapons will most certainly be developed in the course of time. In fact, even more terrible weapons than the present-day atom bomb are said to be in sight. Moreover, the history of warfare has also shown that the threat to use a new and more destructive weapon can at least maintain a truce, but can never preserve peace.

Of course, only the major powers of today have the technical resources and the

scientific knowledge to produce the atom bomb or even more terrible weapons. What about the peoples of the world are industrially backward and who nevertheless, wish a place in the sun for themselves? Their case was simply presented by Marshal Tito of Yugoslavia a statement that has received scant public attention. Tito said that patritic, freedom-loving peoples can never be intimidated by the threat of the atom bomb. And history is in Tito's side Conquerors and oppressors have gone forth in the past with ever newer and more violent weapons to subjugate other peoples, but they have never succeeded in permanently crushing the spirit of the subjugated peoples.

IF FURTHER PROOF were needed to back up Tito, one has only to remember that primitively armed and even totally unarmed peoples in Syria, Iraq and India have stood up against the might of the British and French imperialists, and, to witness, the Indonesians today are fighting the British, Dutch and Japanese forces, often with nothing more modern than spears and bows and arrows. It is to be noted that peace is being violated today, not by armed conflict among the major powers but by the desire of the imperialist powers to continue colonial exploitation. The colonial peoples have heard of the atom bomb, too, but that has not silenced their demand for freedom.

No, the atom bomb will be as powerless to preserve peace as were the mighty weapons of the past. Peace will descend on earth only when man ceases to exploit man.

Bulletins From Britain

The great victory celebrations in London on June 8th.

LONDON, June 6th.—On June 8th Britain will pay a whole-hearted tribute to her fighting men and to the soldiers of the nation who helped to bring about the utter defeat of the Axis powers. The people of Britain realise that all is not well with the world—the threath of hunger lies over many lands, but on June 8th, watching one of the greatest processions of allied nations ever held, the British people will applaud the men and women who fought for the liberty and freedom of mankind, writes a London correspondent today.

Already decorations have appeared on the building lining the route. They are not lavish or expensive, but window boxes are gay with flowers, and flags and bunting are hanging from the roofs and balconies, and a festive note though they are often hiding scars made during the days when London was the target for many bombs.

That Britain can hold up her head in pride at her share in saving the world from Nazi aggression and that her amazing effort and self-sacrifice should be marked on the first anniversary of victory by celebration such as those planned for June 8th is as it should be. That is the opinion of Brigadier General Ramón Rodríguez, head of the Mexican contingent now in London to take part in the parade. During an interview on June 4th the Mexican soldier spoke of his admiration for Britain: "I find that even with rationing and the present hardships the people of Britain are still showing the splendid spirit that won the war" General Rodríguez said.

From all over the world allied and British soldiers have arrived for the great occasion, and at a special saluting base erected in the Mall, Their Majesties the King and Queen, together with the Princesses Elizabeth and Margaret Rose and other famous personalities, will watch the great parade after the marching columns with all their war equipments have passed through the venerable streets of the Empire's capital.

TRADE WITH RUSSIA FAILS

FINLAND'S BIG WOOD CONTRACT

Anglo-Russian trade is at a complete standstill. All outstanding balances of deliveries for orders placed by the Soviet during the war have been completed and there is no sign of any new contracts.

The same applies to imports from Russia. Shipments to Britain of Russian timber and plywood have ceased altogether; all attempts to negotiate future contracts have failed.

The Russian Wood Agency in London—the Soviet official body responsible for trading with Britain in all types of timber and plywood—can do nothing without reference to Moscow, and so far no indication is available on what quantity of timber Russia would be willing to supply to Britain.

British manufacturers of machinery, machine tools and electrical equipment, who worked in the past on Russian orders, have in the meantime filled their books with orders from Empire and other countries. Some of these manufacturers have expressed doubt whether they would now be in a position to accept additional Russian orders.

It is emphasised in industrial circles that if a financial agreement is reached British manufacturers will do their utmost to supply Russia with her urgent requirements.

It seems that the British Government's offer to Russia for a short term export credit for the value of about £ 30,000,000 still stands, and if negotiations were resumed this offer could form the basis for discussion.

In contrast to the difficulties experienced in securing Russian timber, an agreement has just been reached with Finland for the shipment to Britain of 60,000 standards of sawn timber, 35,000,000 cubic feet of pitprops, and 2,250,000 cubic feet of plywood. The proceeds of these shipments, amounting to £ 5,000,000, will be spent by Finland on machinery and equipment in Britain.

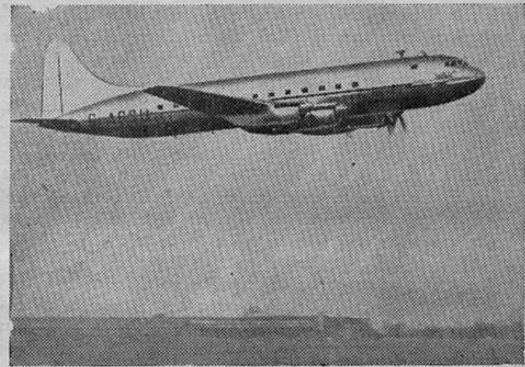
The new queen charlotte's

The Queen recently paid a visit to Queen Charlotte's Maternity Hospital, which, its old Marylebone Road days forgotten, is now housed in splendid buildings at Ravenscourt Park in the west of London. Her Majesty inspected in particular the new nurses' home, which anticipates, so far as building and institutional arrangements can do so, the Ministry of Health code on nursing conditions. The Bernhard Baron memorial staff home, which is ultimately to house 135 Queen Charlotte's nurses, is the most modern expression of the endeavour to ensure the comfort and health of the hospital nurse. It includes sitting-rooms, lounges, and a library as yet unfurnished. One innovation is six private rooms for pupils studying for examination or for nurses wishing to write letters or receive visitors, who may be of either sex. The teaching school, with its roomy class-rooms and its wards with dummy patients, is in the same building.

Every nurse has a separate bedroom, attractively furnished, and every sister a bed-sitting room and small dressing-room. Many of the bedrooms have french windows leading out on to balconies or a terrace roof. There is one bathroom for every four nurses. A sunny sick-bay with five windows is provided. The cafeteria-restaurant for the medical and nursing staff is equal to the dining-room of a good class hotel, and beyond it are ample kitchens for staff and patients, these kitchens are equipped with all kinds of labour-saving devices, and have a system of ventilation so perfect that no smell of cooking penetrates beyond. The patients' food is served from electrically heated chromium-plated trolleys wheeled from the kitchens. The six acres of ground in which the hospital stands grow fruit and vegetables for staff and patients, while 170 hens provide two eggs a week for everyone.

The modern Queen Charlotte's in which there are between 2,000 and 3,000 confinements a year, has now 135 beds and 123 cots open, its full complement being 200 beds and 175 cots. Its nursing force average five to every four patients. The main patients' block has an unusual number of delivery suites and large tiled sluice-rooms. No ward has more than six beds, each bed surrounded with cubicle curtains on noiseless rings, and there are many one-bed and two-bed wards. A department for X-ray pelvimetry is established. Antenatal, postnatal, and in-

AVRO TUDOR 11, NEW BRITISH AIR LINER



Much of the wartime experience in the manufacture of the Avro Lancaster has contributed to the production of Great Britain's newest and largest airliner - designed and manufactured by A. V. Roe and Co. Ltd. in close collaboration with the Technical Branch of British Overseas Airways. The Avro Tudor 11, a passenger or freight transport, is powered by four Rolls Royce Merlin engines with a wing span of 120 feet, a length of 105 feet and a height of 24 feet. Maximum speed is 325 m. p. h. at 20,000 feet, Range with 60

passengers is 1,850 miles at 230 m. p. h. at 20,000 feet. Range with 9 tons of cargo 1,100 miles at 200 m. p. h. at 10,000. It is estimated that between 40 and 50 aircraft will be completed by the end of this year - aircraft which are suitable for operation on any airline in the world. The Avro Tudor 11 is also to be manufactured in Australia and Canada.
