Declaracion De M. Di Giorgi

Tres semanas há, más ó menos, The Gleaner publicó algunas noticias sensacionales, acerca de un acuerdo mandado presentada ante los Juzgados de Costa Rica por la Atlantic Fruit & Steamship Company contra los señores Lindo Bros, en la cual se reclama el cumplimiento de un contrato celebrado, según alegan los demandantes, entre ambas partes ó en caso contrario, daños y perjuicios hasta por tres millones de dólares, por falta de cumplimiento del contrato.

Casi simultáneamente, publicamos la traducción de una exposición hecha por Mr. Cecil V. Lindo al Editor de un periódico costarricense. En ella presenta Mr. Lindo el asunto desde el punto de vista de los señores Lindo Bros. Nuestros lectores recordarán, sin duda, que Mr. Lindo afirmó ó poco menos, que la Atlantic Fruit & Steamship Company, se hallaba en grandes dificultades financieras y que el señor di Giorgi había faltado al contrato celebrado primordialmente, por el hecho de haber querido cambiar su tenor.

Hoy día, The Gleaner, relata los hechos según la exposición que de ellos hace la Atlantic Fruit & Steamship Company.

Transcribimos á continuación el texto de la declaración juramentada por el señor José di Giorgi, Presidente de la Compañía, ante Mr. R. J. M. Bullowa, notario público, en la ciudad de Nueva York, el 31 de mayo próximo pasado:

Yo, José di Giorgi, domiciliado en 171 West 71 Stait, Nueva York, Estados Unidos de América, juro y declaro lo que sigue:

El día 19 de Septiembre, aproximadamente, regresé á Nueva York, procedente de Nicaragua, Mr. Charles Pringle. Al volver á Jamaica, pasó por Costa Rica y en este último país, fué en donde tuve ocasión de ver á Mr. Lindo. Relatóme Pringle que Mr. Lindo dirigía amargas quejas contra la United Fruit Company, al mismo tiempo que manifestaba hallarse él dispuesto á venir á Nueva York, en caso de que yo pudiese ó quisiese entrar en arreglos con él.

Yo hablé detenidamente con Mr. Pringle sobre el asunto, y le dije que no estábamos en condiciones de poder adquirir las propiedades de Mr. Lindo, por no disponer del efecto necesario para realizar una operación de tal magnitud; pero Mr. Pringle me respondió que estaba yo en un error, que Mr. Lindo iba á suspender sus relaciones comerciales con la United Fruit Company de todos modos, y que en opinión suya, se podría celebrar un arreglo, en virtud del cual se haría un pago parcial en bonos ó acciones ó podría formarse una nueva Compañía.

Dije entonces á Mr. Pringle que, si le parecía oportuno, escribiré ó cablegrafiaré á Mr. Lindo y si Mr. Lindo quería venir á Nueva York, celebraría mucho su llegada y escucharía con gusto lo que tuviera que manifestar y si yo quisiera, le escribiría. Mr. Pringle me dijo que Mr. Lindo era que le anunciaba dicho señor su viaje á Nueva York. A su llegada, fué recibido por Mr. Pringle quien se encontraba toda en esta ciudad. Mr. Pringle me preguntó si estaba yo dispuesto á recibir á Mr. Lindo, pero rehusé hacerlo, indicando que recibiera á Mr. Lindo y tratara con él, siendo así que yo no tenía deseos de verlo, salvo que fuera á arreglarse el negocio.

En realidad, yo no deseaba ver á Mr. Lindo, hasta después de haberle hablado Mr. Pringle y de haber éste averiguado si realmente había probabilidades de entrar en arreglos con él. Mr. Lindo llegó como á las 12 a.m., y á las 4 p.m., aproximadamente, Mr. Pringle me llamó por teléfono, al Knickerbocker Hotel, preguntándome

si estaba dispuesto á tratar de negocios; y, en consecuencia, acompañado de Mr. A. W. Farquharson, fuíme al Hotel, en donde me encontré con Mr. Lindo. Antes de hacer mención de precios, dije á Mr. Lindo que no deseaba tratar de negocios con él, en caso de que aún tuviera relaciones con la United Fruit Company, y le expuse el motivo siguiente:

"Durante los últimos años, habían llegado varias personas á entrar en negocios conmigo, y después de adquirir algún escrito mío, no valían ya, llegando yo á saber poco después que esas mismas personas habían de celebrar contratos con la United Fruit Company. Mr. Lindo es sólo una excepción á esta regla, persona de pé,

y estar dispuesto á tratar de negocios conmigo, pudiendo nos tres confiar en cuanto nos dijera, que yo no pambra e ig ba; me refirió además, haberme dicho el Administrador de la United Fruit Company que se dirigía á Nueva York, con el objeto de vender sus haciendas á la Atlantic Fruit and Steamship Company y á los de Jamaica, que si deseaba tratar con él, lo hicieran antes de su llegada á Nueva York; dijo también que ya no quería hacer negocio alguno con ellos, después de su llegada á los Estados Unidos, así suponiendo que yo ó la Atlantic Fruit and Steamship Company no cerrarían trato con él. Dijo que, al no ver dentro sus fincas, se arreglaría de modo que pudiese mantenerse poseedor de la fruta de su propiedad.

Me fué entonces á Mr. Lindo halarme dispuesto á eximir los cálculos por él preparados, y hecho esto, entramos á tratar de precios.

El me dijo que quería \$ 3,000,000 el contado, contestándole yo que nos era imposible conseguir \$ 3,000,000 al contado por ahora, por cuenta de la Atlantic Fruit and Steamship Company y que no haría cargo de conseguir esa ni otra suma de dinero cualquiera con el objeto de adquirir nuevas propiedades, y le dije explícitos los motivos que me lo estaban haciendo imposible.

No obstante, dije que me gustaría obtener de él una opción, en condiciones favorables, sin obligación alguna específica; por parte suya, precisando yo, en cuanto me fuera posible, cerrar el negocio, siempre que él lo aceptara en la forma por mí presentada. Le expliqué que deseaba que yo creara una nueva compañía con un capital de \$ 1,000,000, en acciones pagables en cinco años, en un 10 por ciento, y me dijo que me daría un 10 por ciento de las acciones que yo creara. Me dijo que yo podría comprar las acciones de la United Fruit Company sobre sus haciendas, hipoteca y por ascendencia á \$ 600,000; pero no urgía su cancelación, si nosotros no nos seáramos hechos, pudiendo, en tal caso, la nueva Compañía comenzar luego de los abonos mensuales debidos, según contrato existente.

Seguí á la vez la idea de formar una Compañía, con un capital de \$ 2,000,000 en bonos ó acciones principales y \$ 1,000,000 en acciones ordinarias; yo procuraría vender la mitad de los bonos quedando nosotros en la obligación de tomarle algo más de la mitad de las acciones en cambio ó en pago de la misma suma de acciones ordinarias de la Atlantic Fruit and Steamship Company. Ahí he sido mención de acciones ordinarias, me dijo que, en este caso, quería \$ 150,000 en acciones ordinarias.

Tratamos el asunto largo y detenidamente, y al fin llegamos á ponernos de acuerdo y entonces Mr. A. W. Farquharson escribió de su puño y letra el contrato que lleva el número 1, que fué firmado por Mr. Lindo y por mí en el Knickerbocker Hotel.

Al día siguiente se copió dicho contrato en máquina de escribir y se presentó al original manuscrito por Mr. Farquharson, número 1, el cual fué destruido.

Lindo díjome entonces que no era de su agrado el contrato, porque, al formar una nueva compañía, las fincas de Costa Rica, dirían que él había pagado, vendiendo sus intereses, sin hacer absolutamente nada en pro de los otros productos de bananos de Costa Rica. Manifestó que en realidad su deseo era que la Nueva Compañía fuese á este país, adquiriese terrenos á nombre de ella misma, no sólo por nocentías á él, sino también á otros propietarios y cotizara precios sobre la fruta; en resumen quería el hacer entrar á Costa Rica

en la explotación y el negocio de bananos, que no le preocupaba mucho el hacer para él mismo, pero antes de eso, él, hacer algo en pro del país, á donde había llegado gastando \$ 75,000 mensuales, en donde había hecho la respetable fortuna que hoy posee y en donde se hallan todas sus propiedades.

Relató enseguida, con largos detalles, lo que sucedía en Costa Rica, al momento de dejar él ese país, que todos los productos

de bananos elevaban protestas contra la United Fruit Company, y que negociaban. Concluida su exposición, dije que, dados sus motivos, arreglaríamos una nueva opción número 2, lo que fué hecho.

Mr. Lindo entonces manifestó deseos de ver destruido el número 1, á lo que me negué yo, explicándole que por los motivos á él expuestos por mí, en la noche precedente, me era más fácil llevar á la práctica el número 1 que no el 2.

Ambos, al fin, venimos á firmar el número 2, y el partido para Costa Rica, algunos días después. En el mismo día en que firmamos este contrato, segundo por el firmado en Nueva York, dio al reportes del "Journal of Commerce", en Nueva York, detalles completos de haber vendido sus propiedades á nosotros, y me informó también que había comunicado al señor Borgis, dueño de un periódico de Costa Rica, quien trabajaba en Nueva York, á quien tuve el gusto de conocer al día siguiente, que en Nueva York se había publicado en su diario la relación del negocio efectuado por Lindo Bros, ó sea la venta de sus haciendas á la Atlantic Fruit and Steamship Company. Vi después un periódico costarricense de propiedad del caballero antes mencionado, que traía una fotografía de Mr. Lindo y una mía, al lado una de otra.

Entré luego en gestiones para conseguir el dinero que me hacía falta para adquirir las fincas de Lindo Bros, y mostré ambos contratos á un banquero de Nueva York, quien me pidió una opción de diez días, sobre el contrato número 1, manifestándome que, en tal caso, no tendría dificultad alguna en vender \$ 1,000,000 en bonos ó acciones principales en 10 días; más yo me negué á concederle dicha opción, alegando que me oponía no poder complacerle, por haber prometido á Mr. Lindo gestionar primero en pro del contrato número 2, y que cumpliría la palabra empeñada. Hecha circunstancia me ocurrió con un segundo banquero.

Intería Mr. Charles Pingle y Mr. George King fueron á Costa Rica para dar informes. Pocos días después de recibir éstos, Mr. Cecil Lindo llegó á Nueva York con deseos de averiguar á qué altura me hallaba financieramente, en la empresa de obtener dinero para comprarle sus fincas y le respondí que casi se estaba cerrando las gestiones. Dije al propio tiempo que muchas dificultades se presentaban para conseguir dinero para la opción número 2, habiendo ya rechazado yo dos proposiciones hechas para la opción 1 y él me suplicó que desistiera de tomar en cuenta la opción número 1, siendo así que su hermano no aceptaba el contrato, por ser.

DESINO PARA ELLOS

Mr. Lindo permaneció aquí por espacio de unos días y me preguntó un día que quien gestionaba los asuntos. Dije que yo, Mr. Boas, Administrador General de la Hamburg American Line y uno de los directores de nuestra Compañía. Dije que nada tenía que ocultarle, que las gestiones iban adelantando muy bien y que podía pedirle informes á Mr. Boas mismo, sobre el estado real de las negociaciones.

Mr. Lindo estaba algo inquieto, me comunicó que había adquirido otras fincas, que si no las tomábamos, tendría que procurarse el dinero en otra parte y que deseaba hacerme saber de ello, antes de su partida para Europa, que debía ser una semana después más ó menos.

Al punto que procurábamos una entrevista y fuíme á Mr. Sichel, asistente de Mr. Boas, para verse con Mr. Lindo y con migo.

Explicó á Mr. Sichel el motivo que hacía esta conferencia necesaria y quedó acordada y Mr. Lindo y yo fuimos introducidos á la oficina de Mr. Boas, á donde llevamos un plan de sus propiedades.

Habíamos de la situación de Costa Rica, de un modo general y tras larga conversación, Mr. Boas expuso á Mr. Lindo el estado exacto del asunto.

Se están haciendo gestiones para que esta Compañía suministre el dinero á la Atlantic Fruit and Steamship Company; y aunque no se ha recibido aun una respuesta favorable, no creo que usted tenga motivos para estar intranquilo.

Profundicé más el asunto Mr. Boas y dió detalles, que no creo oportuno repetir ahora. Mr. Lindo siguió conversando con Mr. Sichel, Mr. Boas y conmigo y expuso los perjuicios que él podría causar á la United Fruit Company.

Primero, que el Gobierno de Costa Rica, podía abrir un nuevo puerto y lo haría así, ocasionándole esta empresa gastos bastante reducidos. Que existía también otro modo de perjudicar á la United Fruit Company, caso de que ésta procurase luchar con la Atlantic Fruit, á saber: comprarle á sus fincas y las otras que adquiriera por el posteriormente, pues estas fincas reunidas producen la mitad más ó menos de los bananos de Costa Rica, añadiendo que si bien era cierto que por contrato celebrado con la United Fruit Company teno que entregarse á ésta todo el banano de su propiedad, no le era menos que no necesitaba el banano

dos años más; que sería excelente medio cortar cuantas matas de banano tuviera, por espacio de un año, rebajando de este modo la explotación de la United Fruit Company, la que no podría continuarla y causando así la ruina á la United Fruit Company en Costa Rica. Además esto, según él, habría de producir inmensos beneficios, en las fincas de bananos y al momento de recibir nosotros las propiedades, nos daría fruta en mas abundancia, siendo en la práctica, las pérdidas despreciables, y casi nulas; esto sin contar que, faltando de la venta la fruta así cortada, obtendríamos mejores precios por la que nos produjera estas fincas de que podríamos disponer en otra parte del país; "resultando así un magnífico negocio para nosotros.

Dos días después celebramos una reunión en las oficinas de la Hamburg American Line y Mr. Boas puso en mi conocimiento que algunos banqueros tomaban ya interés en el asunto y deseaban verme.

Me dirigí á sus oficinas, en donde me hicieron las preguntas de costumbre, sobre el negocio. Yo les di todos los informes que me fué posible y pregunté á uno de ellos si tendría gusto en recibir á Mr. Lindo. Respondiome que ello le proporcionaría gran plazar y llevé á Mr. Cecilio Lindo á la oficina del banquero, en donde le dejé con un mapa de sus haciendas. Ignoro lo que haya pasado entre ellos dos; pero si me consta que, después de la visita de Mr. Lindo, el banquero quedó muy interesado en el asunto.

La víspera de la partida de Mr. Lindo para Europa, más ó menos, recibí aviso de los banqueros, en que me anunciaban que, en caso de aceptar el negocio, no sería en calidad de una opción por bonos, pues que, á su modo de ver, las acciones principales ó preferidas eran lo mejor en asuntos de la naturaleza del actual; que habían exa-

minado los contratos celebrados entre la Atlantic Fruit and Steamship Company, y Lindo Bros, notando que al aceptar nosotros la opción n.º 2, quedaríamos obligados á entregar á Lindo Bros, como abono parcial, \$ 4,000,000 en bonos de la Atlantic Fruit and Steamship Company, al retirar los bonos no saneados, tendría que hacer se arreglos con Lindo Bros para que aceptaran acciones principales en vez de bonos.

Explicué á Mr. Cecilio V. Lindo en mi Oficina y en presencia de Mr. A. W. Farquharson, en la tarde de la víspera de su partida para Europa, lo que pensaban hacer los banqueros y él me respondió: «Di Giorgi, no se preocupe usted sobre el cambio que se de hacer, aceptando acciones principales en lugar de bonos. Pondré cuanto esté de mi parte, para que salgamos airosos. Bien puedo yo llevar á cabo este negocio. Procure obtener la propuesta de los banqueros por escrito y no se preocupe de mí».

Al día siguiente, se embarcó para Europa Mr. Lindo.

Poder General

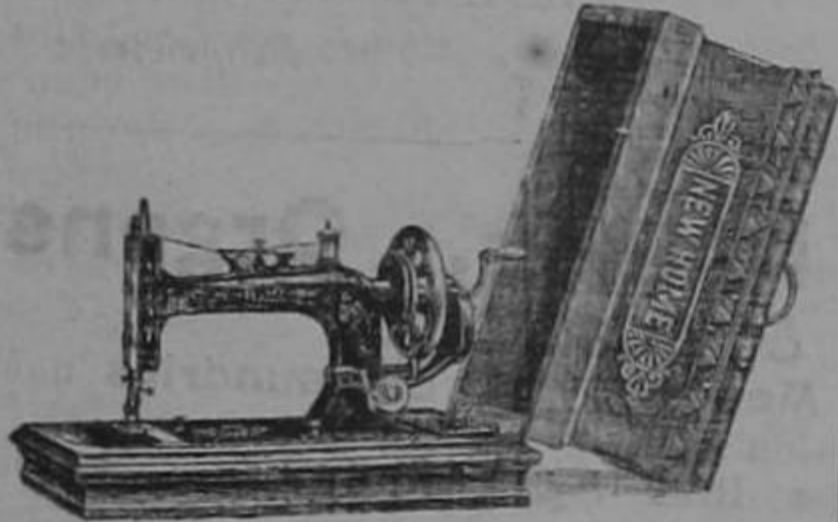

Of Animals

On Wednesday night 26th inst., it is said that some wicked person entered the property of Mr. G. T. Sanderson at Blagdon, cut the pen gate of his Corral where he had his working stock enclosed for working next day on cutting his bananas. The gate by the Railway line was also found cut away with the result that the animals came out and took the Railway lines towards Sandoral when they were met by the early morning train, killing five mules and one horse. Consequently no fruit could be cut by this unfortunate man on his plantation, as his pack and only draft mules were among the lot killed.

This loss to Mr. Sanderson is estimated at 1,500 colones, apart from the loss of his fruit from not being able to cut.

The Company asked permission to watch over the farms to see that the bananas are not robbed, how is it that they did not watch over the stock that get the bananas out for them? Or is it the watchmen that help to let out these stock so as to be better able to patrol the banana fields?

Contradicting Stories.

We notice in an article of "La Information" that Mr. Mullins says that on Friday of last week while the Atlantic were buying fruit there were fifteen cases of robbery of fruit from the U. F. Coy. Yet he did not make any arrests, for all he had 100 policemen at his disposal; but strangest of all is the fact that Mr. Agüero who was in charge of the police detachment sent specially to keep order and protect property, says in his report that nothing occurred against law and order; what is the meaning of this? All this goes to prove that some very false representations have been made.

In this interview Mr. Mullins also is reported to have said that no objections whatever was put in the way of the officials of the Atlantic Fruit Coy. by the officials of the U. F. Coy. and yet we hear of lots of threats being used along the lines to the paries putting out their fruit on the Railway track for the Atlantic. Who are the truthful ones in this matter?

Serious Complaint

A very serious complaint has reached this office wherein it shows that some of the high officials of the Railway Coy. and U. F. Coy. have been trying to implicate one of the men working for the Atlantic, by offering a man named Soars twenty five colones to say that this man Allan Howard incited the labourers on the coal boat to strike, had this individual accepted the 25 colones poor Howard would have been arrested so as to get him out of the way. Howard is well known to Officials of the U. F. Coy. as a hustler, having worked for this company as labour agent for about 7 years but is now working for the Atlantic. If this be true, such a matter ought to be brought

before the tribunals, because we are living in a peculiar age and these occurrences ought to be set upon as these actions may put any innocent man in prison.

CARELESSNESS ON RAILWAY.

In another column we publish a report of the loss of 5 mules and a horse caused by carelessness of the Engineer of the train that went out on the morning of the 26th inst. Surely there must be some law governing this reckless manner some Engineers have of running into animals along this line. In every civilized country this procedure is prohibited and the Railway Companies have to pay the cost of their carelessness, and we do not believe that Costa Rica is any way behind other countries by way of protection to life and property when properly looked after. It is only a few weeks ago that we reported a criminal act of carelessness when an Engineer rushed into a number of animals at the Cemetery at one mile without blowing a whistle or sounding a bell, consequently killing a mule with impunity. Again the same thing occurred at Rio Bartola when a fine mule and a mare was picked up on the East approach of the Bridge and carried across to the West and without any regard to consequence, and now worst of all comes the news of the damage of six heads at Blagdon. Can it be possible that an Engineer can plead innocence in running into such a quantity of animals without thinking of the possible consequences to his train? Along the F. C. R. the lands were for the most part ceded by the Government for the construction of the lines and certainly as such some arrangements must have been made for the protection of life and property along these lines, considering that there are no other roads available, but on the Northern lines, the lands are ceded by the owners of the property through which they pass free of cost, as provided by a clause in the Banana Contracts, hence it is only natural to expect that the Company would protect the animals of the plantations along the lines, rather than apparently designedly run into these brutes, as they cost nothing.

We understand that there is a law governing these actions, and we hope the Government will help us towards seeing this law put in operation in this division as it is done in the interior.

First Hospital Ship Built

From the Jamaica "Times" we take the following:—

In next year the Admiralty hope to launch the first ship in the world to be built as a hospital. The ship will have a tonnage of 5,000 and will cost about £100,000. There will be accommodation for 260 patients in peace and 330 in war time and the staff will include 8 medical officers and 40 nurses. Two operating theatres and bacteriological, dental and X rays room are fitted. Vibration will be lessened by the use of turbine engines and bungee knees will reduce rolling. Comfortably fitted motorboats will carry the wounded from their ships. Transference to the Hospital will be by means of canvas cots controlled by electrically driven cranes. Then in specially fitted lifts the patient will be taken to one of the twelve wards.

Other Embargoes.

We learn that two embargoes were made by the U. F. Coy. yesterday at Germania and two at Guacimo, on farms belonging to small settlers, who have been supplying their fruit to the Atlantic Fruit Coy. We have not yet seen the cause of the embargo. Where will all this end?

Law Disallowed.

The President has been pleased to disallow the law passed for permitting Cock fighting in the country. The lovers of this sport in Limon were much elated when the law was passed and several new birds were bought, but now that there can be no more cock fights they are much dismayed.

Another Law

A law is also on foot for repealing all the laws governing the public sales of Government lands of the country. To those who are in the circle it is thought that the recent sales of Baldios on behalf of the Municipality of Palmares of a week which brought the fabulous amount of 50,000 colones will be the last amount of government lands to be sold under the old laws.

Cargoes of Fruit, The Latest News

The Hamburg American steamer Sarnia, arrived last week at Hamburg and Holland with her third cargo of fruit from Puerto Cortez in first class condition. Half of this cargo was landed in Holland while the other half went to Hamburg. The Sarnia ought also to have arrived there by this time with her second cargo from the same port all consigned to the Atlantic Fruit

The entire train load of fruit taken up by the Atlantic was embargoed by the U. F. Coy. even the fruit that was not taken up between Moin Hill and Limon was also embargoed on the platform and not allowed to be touched. Mr. Chittenden was named depositario but Don Cleto Gonzalez came down by 4 o'clock train and demanded the irresponsibility of that gentleman and named Don Victor Fabian

False Rumours

Like the other statements with regard to the banana question, the statements made by "La Informacion" that Don Cleto Gonzalez Viquez was called to the States on important business relative to the Atlantic Fruit Coy., has been the lie. Don Cleto says the first notice he had of this trial was when he saw it appear in the journal referred to; otherwise he knows nothing of the proposed trip. Where did the rumour come from, is this another special cable similar to that re the deterioration of the shares of the Atlantic?

Feasts of Sleuthism

Some very fine feats of shadowing are being put in evidence during the race being run between both companies. A week ago a first class ticket was played by Mr. Vanscriver on Mr. Lerett the U. F. Coy's. Notice man, the former in charge of the fruit purchasing for the Atlantic Fruit Coy. between 12 Miles and Matina while the latter was set to shadow him and see what were his operations. By no means could Mr. Vanscriver get rid of Lerett from morning on Friday he shadowed him, if he went to Matina he went too, if he went to Zent he was also there, if he stopped to buy a stem of fruit he was witness to it, finally when the passenger train came along, Van decided to slip him, he bought a ticket for Limon, but Lerett was also there, they took the same seat Van of course widely exposing his ticket so he could see his destination, suddenly Van got up and went on the platform of the car to converse with a man, by this time Lerett leaves his seat and gets near the door catches himself on the recline of a seat. The train arrives at Saboria and after she has left Lerett peeps out and satisfies himself that his man was there, but Van is a Railroad man and knows to do it, and when the train was at high speed he skips off leaving his shadower in the full conviction that he was on board, as he could never conjecture that the old Van was so sly, but when he got to 12 Miles he found his mistake and knows then that the old man was foxy enough for anything.

Rumour has it that the fruit embargoed here by the U. F. Coy. has been re-embargoed by the Atlantic Fruit Coy. in the United States because there was no authority to ship embargoed fruit.

We understand that a Commission has been named in San Jose to come down and enquire into these actions here. Between Estrada and 15 Miles, Mr. Elvir informs us there were no less than 36 watchmen for the U. F. Coy., all armed, they looked like bandits he says, so much that he was afraid of these desperate looking men as he had money on him buying fruit.

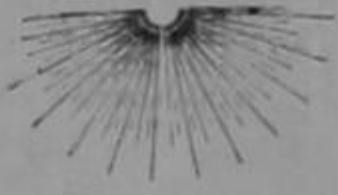

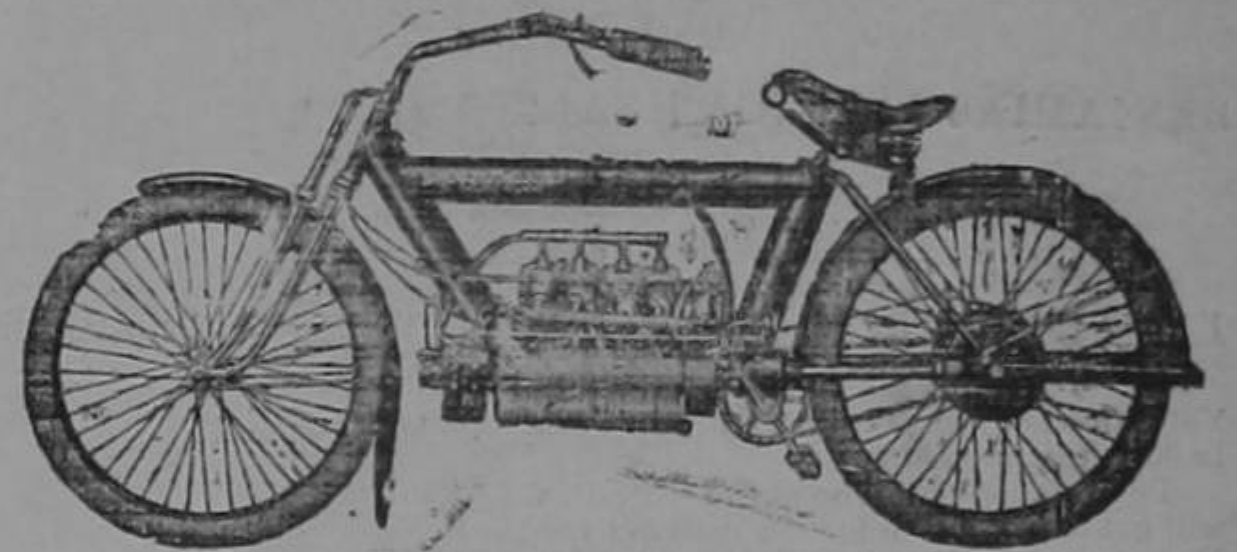
