Contra la Ley

En nuestro número del martes, hablamos aunque ligeramente del campamento de peones que la United Fruit Co tiene levantado en una de las principales calles de la población; hoy queremos tratar este asunto con más extensión.

Entre las muchas razones que pudieramos aducir para atacar la permanencia de dicho campamento, hay algunas de suma importancia que se debieran tener en cuenta, puesto que caen bajo la sanción de la ley.

Según el Reglamento de Construcciones Urbanas de la ciudad de Limón, los dormitorios se deben computar a razón de veinte metros cúbicos por persona, y como este reglamento está en vigencia, y además, es autorizado por el ex-Presidente González Víquez, pasa a la categoría de ley; la extensión del campamento a que nos referimos, no alcanza a mil metros cúbicos y duermen allí en la actualidad más de cien personas.

Las Escuelas Públicas están situadas junto a este campamento de peones, y los escolares y las maestras tienen que pasar diariamente por frente de este campamento, donde los peones se entretienen en hacer juegos de palabras bastante verdes y algunas veces ademanes y señas que están más que refidos por la moral más trivial. Lógicamente hay en esto un peligro para la juventud que se educa y es absolutamente indispensable que, retire de junto a la escuela este foco de inmoralidad, porque quien anda muy cerca

de la miel, algo se le pega como dice el refrán. Esto, claramente hablando, cae también bajo la sanción de la ley de policía y está calificado como faltas a la moral lugar en público.

La falta de aseo en las clases bajas del pueblo, es bien conocida del público, de consiguiente, allí donde se reúnan para vivir en comunidad más de veinte personas que no conocen la higiene ni el aseo, tendremos mos siempre un peligro para la salud del transeunte y de los vecinos. Luego este hecho cae también bajo la sanción de la higiene.

Como asunto de estética deja también mucho que desear porque es poco artístico para el ornato de una población, ver en las calles más centrales una especie de galerón propio, más para caballerizas que para habitaciones de hombres.

Podríamos anotar algunos puntos más, contra la permanencia de dicho campamento, pero nos parecen más que suficientes los ya anotados, y creemos que las autoridades, con el alto espíritu de la justicia que las distingue, deben investigar este asunto, puesto que como queda dicho, peca contra la ley, contra la moral, contra la higiene, y contra la estética, razones suficientes para que se proceda cuanto antes a quitarle del sitio que hoy ocupa, ó suprimir, en caso contrario, las leyes y los reglamentos que lo prohíben. La ley ó se hace cumplir, ó se suprime.

que llegue el caso de que se presenten luchas sangrientas sin que de algún modo se tomen medidas para evitarlo? ¿Dejarán los miembros del Congreso, con la calma con que se ven las cuestiones graves como la presente, que le están sometidas para su conocimiento y resolución, de proceder a la revisión y reforma de nuestro Código Civil y de Procedimientos Civiles, tratándose de un caso tan apremiante, cuando de tales hechos pueden surgir trastornos internacionales que amenazan la soberanía de nuestro país? Hay que tener muy presente lo sucedido en Cuba, en Panamá, y en nuestra hermana la República de Nicaragua. Hay que evitar los escollos de ese orden y esto solo puede hacerse con leyes.

En las situaciones difíciles, nunca faltan elementos que atizen el fuego: hoy hemos sabido, causando en nuestro ánimo honda pena, impresión dolorosísima, que un rico potentado muy interesado en el conflicto de ambas Compañías fruteras, queriendo instituir en nuestra República uno así como trust unipersonal, ha amenazado a comerciantes de la Línea, con no venderles hielo, si no le compran cervezas y refrescos; es decir que además del conflicto bananero, se presenta por obra y gracia de este señor, el conflicto del Comercio, casi en estado ruinoso hoy, desde que la poderosa United Fruit Company fundó los Comisariatos en la Línea, ejemplo seguido por el no menos poderoso señor á que antes nos referimos—con sus correspondientes cupones.

Lo de la obligación (de C.) contratada por esta Compañía en los contratos respectivos para que pague en oro el salario de sus trabajadores, es un mito de algún tiempo a esta parte, porque como esa Compañía todo lo aprovecha, desde las famosas quiebras de banqueros y trust en los Estados Unidos no queriendo perder el tanto por ciento que le produjo la negociación, recogió el oro circulante en esta Provincia y allá lo mandó pagándose desde entonces en colonos.

A trabajar con decidido empeño, señores Diputados, para dar al traste, de una vez, con estos repetidos abusos.

Los grandes inventos

La máquina de vapor

1651.—Era de Adán. Un ingeniero francés levantó agua de un pozo a una caja situada sobre él; calentó ésta, y entonces condensó el agua y quedó el vapor.

1663.—El Marqués de Worcester inventa una máquina que levanta agua por la presión del vapor.

1698.—Un aparato para levantar agua por vacío y por presión es patentado por el capitán Savery, inglés.

1705.—Un aparato para funcionar con vapor, con cilindro, pistones y bombas, es patentado por Tomás Newcomen, un herrero de Dartmouth. Le llamó a esta «máquina atmosférica» y se le hicieron notables cambios en 1765.

1765.—James Watt construye una máquina modelo en la cual la condensación se hace en una vacija separada del cilindro, obteniendo para ella su primer patente en 1769.

Watt nació en Greenock en 1732. Teniendo apenas seis años de edad, encontraba en los pro-

blemas geométricos método para divertirse. Estuvo varios años en Londres y alcanzó en 1756 la fabricación de una máquina de vapor, llevándolo sus conocimientos a efectuar en ella las mejoras más importantes, entre ellas la separación del condensador. Watt se asoció con Matthew Boulton para la fabricación de máquinas en gran escala, en Soho, cerca de Birmingham. Introdujo en ellas mejoras de año en año retirándose de los negocios en 1800, época en que se dedicó a sus estudios favoritos hasta su muerte en 1819.

Sigue el Conflicto Bananero

Nos preguntamos: ¿Qué es lo que se propone la United Fruit Company con los repetidos embargos de la fruta bananera comprada por la Atlántic Fruit Company y ya colocada en los vagones, y en la de los pequeños finqueros que al venderla a esta última Compañía sólo procuran mejorar su situación por cierto bien precaria?

No hay duda que siguiendo ese trust bananero el camino emprendido agrava el conflicto, que no será por la derrota que sufra la Atlantic Fruit Company, sino de otro orden: de orden público, porque los finqueros productores en pequeña escala y el número de peones retirados del trabajo por la United Fruit que sufren hoy lamentables privaciones, llegarán a la exasperación y hasta al extremo de repeler de modo agresivo, cualquier otro atropello ó embargo que se traben en el único fruto que le proporciona la subsistencia de su familia, el producto de su trabajo.

La situación de los jueces en propiedad y comisionados para ejercer las funciones judiciales, es harto difícil, porque al presentarse hechos de esa naturaleza, y cumpliendo con su deber, están expuestos hasta a perder la vida.

La United Fruit no se encuentra satisfecha con los embargos que ella

por sí ha solicitado: quiere apretar más el tornillo, y hace que los finqueros en grande embarguen el banano de sus colonos que con regularidad le pagan sus derechos de piso, dando como razón que esos trabajadores están obligados a entregarle la fruta conforme á contratos verbales en su mayor parte; celebrados con ellos. Tal procedimiento es atentatorio: si esos pequeños productores satisfacen al dueño del predio sus arrendamientos, si ellos encuentran quien los remunere mejor el producto de su trabajo, tienen derecho á rescindir esos contratos para obtener del mejor postor el ciento por ciento de utilidad que venía devengando el propietario: á este no le queda otro recurso que el de comprarles los cultivos para que le desalojen la parte del fundo que ocupan.

Estos casos se han presentado ya: primero con la señora Lizzie Cash Arnold, quien en su empeño de complace á la United Fruit ha llegado á obstruir la única vía, que es camino público, por la que escaban su banano colonos y los que no lo son; y 2º (bará tres ó cuatro días el señor Jacinto Xirinacha con los señores Fidel Ocampo Francisco García y otro señor de apellido Torres.

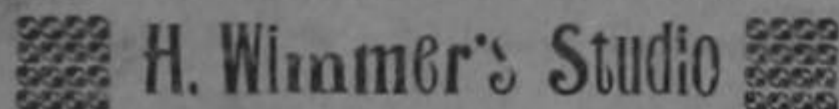

Senate might Enquire into U. F. Coy.

Move by The Atlantic

NEW YORK DEALERS SAY TRADE IS GOVERNED BY TRUST.

(From the Daily Gleaner)

Washington, D.C., June 24—It was understood here today that, acting on complaint made by the Atlantic Fruit Coy. of New York, there would be a demand in the House and in the Senate for a "banana trust" inquiry. It was said democrats would act in this matter before the present session closes. A resolution calling for the investigation of the United Fruit Company was introduced in the Sixtieth Congress, but nothing came of it. Senator Lodge, of Massachusetts, opposed it. The principal offices of the corporation are at Boston. It was declared that the U. F. Coy. has a monopoly of the banana business in America in Colombia, Panama, Costa Rica, and the other Central American Republics the coy. has large interests. One of the company's estates in Colombia is said to be worth 5,000,000 dollars.

It is alleged that the "banana trust" stifles competition; that it has made combinations in restraint of trade and that it drove the Bluefields Steamship Company out of business.

It is said the Atlantic Fruit Company appealed to Washington, saying it feared it would be put out of business and asked that open competition be established in the banana business.

Millions, if not billions of bunches of bananas come into the United States all year round from South America and Central America.

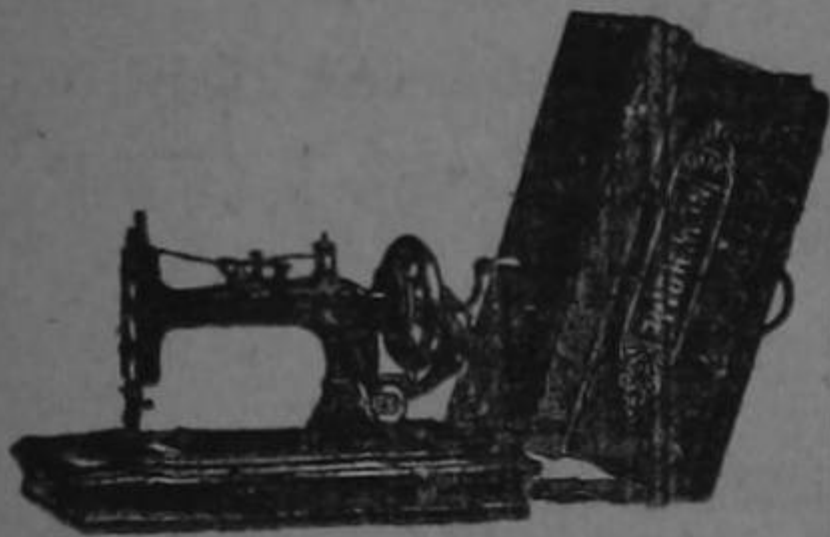

THE COMMISSION.

Why has the Commission returned to San José so pre-emptorily meanwhile their labours have hardly been begun?

This is the riddle that every one who is not on the "inside" of the ring is left to guess. They sat on Saturday all day taking declarations from interested parties, in a square and impartial manner, the task was incomplete for they took statements from 6 or 8 persons there were dozens of others right here in Limon who were notified to come and state how many stems of fruit they supplied, could supply and and from whose lands these fruit were produced and what obligations if any, and they with anyone and with whom. There were several people also waiting at Estrada and other stations along the lines to prove how they came by the bananas that were sold by them to the Atlantic Fruit Coy., but all of a sudden we find the work of the enquiry brought to a close on Monday evening and on Tuesday nothing done, on Wednesday morning all hands pack their trunks for San José. On enquiry we learn that there has been a disagreement between the members of the Commission on certain points, and rather than remain here and cavil over these questions they have decided to go to San José and settle who is wrong.

One of the points we understand is the relationship between tenant or squatter to the proprietor of the lands on which these tenants cultivate. It is said that two out of three agree that where there is no contract with either Coy. or any stipulation in the terms of lease binding him with the owner of the lands to supply any particular individual or corporation, the tenant is at liberty to dispose of his product, how and where he pleases; meanwhile the other thinks that where the lands are obligated to any Coy. the tenants would also be obligated even though it is not so stipulated to him at the beginning of his occupancy.

Of itself this difference of opinion could easily have been solved by a legal decision, but it is said that a little unpleasantness cropped up in the matter of La Amelia and Xirinach's farms, which has strained the feelings a bit.

Of course when Joseph loaded his brethren with corn and oil in Egypt and sent them home, he knew they would have fallen out by the way, because he knew where the cup was, hence his charge was: "Take heed that ye fall not out by the way." We also felt that there would have been a falling out.

We are sorry that this should be so because it tends to throw a bad light on the whole transaction, and in the meantime the industrial conditions around us remain paralyzed; we trust however the President will soon rectify the little discrepancy and send back the Commission to its work.

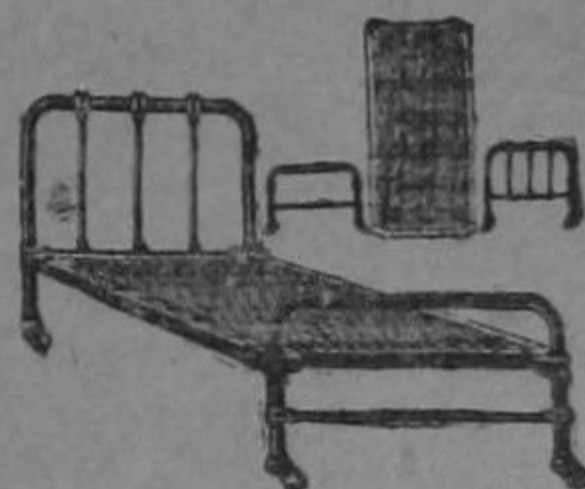

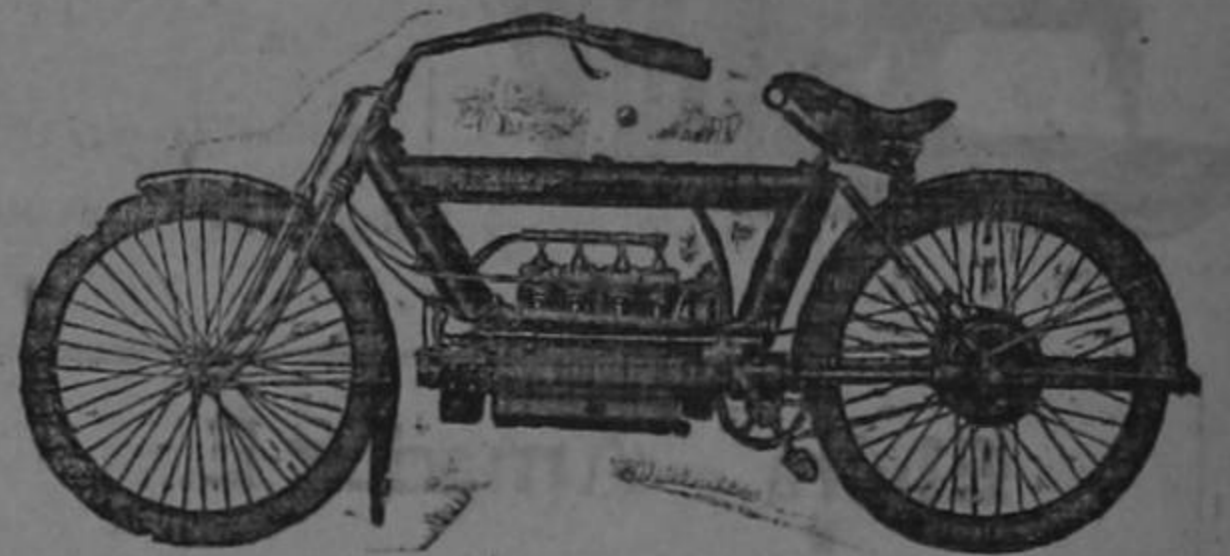
