## La Whence Lie Co de W de la Guardia

Grande esfuerzo tendría que hacer nuestra voluntad para que, en conclusión las líneas que aquí comienzan, no quedara expresada con agravios la indignación que rebosa el alma ante el inmenso daño que a nombre de una compañía inglesa alienta en contra de Costa Rica el señor Wenceslao de la Guardia, y que en forma de proyecto de contrato presentó el Presidente de la República creyéndolo digno de la sanción de la Cámara Legislativa.

Y esta circunstancia de ser el propio Jefe Supremo del Estado—el primero y principal obligado a la defensa de los intereses nacionales—quien hace honor de estimaciones a aquel proyecto, es la que acrecienta la indignación naturalmente producida por el nuevo empeño de la rapacidad misma ya otras veces alimentada en el sabor de gaitos ruinosos para Costa Rica.

Porque está bien que a la conquista de oficiales ó privadas grangerías cuantiosas ó mezquinas se aventuren los que de ellas han hambre y sed insaciables; los que a ellas se consideraran con derecho legítimo ó adquirido clandestinamente; los que para alcanzarlas se disponen a todo sin que un crepúsculo les estorbe ni les detenga un recelo.

Bien está ya que los altos sentimientos son sustituidos en la conciencia humana y ya que contra las inmundicias de hecho ofensivas sólo existe la acción siempre ineficaz de la política,—para la defensa de los individuos—y la relativa utilidad de los pueblos.

A nada nuevo, ciertamente, habría de lamentar Costa Rica si otras inconsecuencias tremendas de sus prohombres pusieran en manos advenedizos el resto miserable de honor, de riqueza, y de bienestar nacionales que unos y otras agotan con inestancia.

Pero ¿de qué sirve a la sola virtud vampírica de los desgraciados de este pueblo el cumplimiento de sus ansias inferas sin que a lo odioso de las privaciones arrebatadas tenga que unir aquel en sus padeceres la afrenta de ver a los propios electos de su confianza abriendo paso a los filibusteros que lo arruinan.

A qué preguntar si existe realmente la Compañía Inglesa en cuyo nombre don Wenceslao de la Guardia propone al Gobierno el más gravoso de los convenios? A qué poner de manifiesto el daño inmenso que a Costa Rica haría la aceptación de aquél? A qué expresar las consideraciones que sugiere ese documento que sería irrisorio si no fuera tan odioso?

Desde el humilde nivel en que nuestra inteligencia se ejercita hasta la empinada altura en que brilla sobre el

país la poderosa inteligencia del Licenciado don Ricardo Jiménez, cada uno de todos los entendimientos hasta por sí solo para comprender que aquel convenio no debía haberse escrito; menos, mucho menos recomendarse a la consideración de los representantes del pueblo contra cuyos intereses se atenta.

Bien puede la compañía inglesa de don Wenceslao haber sido constituida y hasta legalizada jurídicamente. A tantas y tan grandes ilegalidades se presta la legalidad jurídica. No queremos, pues, dudar de la legal existencia de la compañía inglesa, y hasta queremos creer que se llama «Whence Lie Co».

La «Whence Lie Co» puede haberse hecho ocasionalmente para la explotación que se propone, puede constituirse de don Wenceslao de la Guardia y de un hombre cualquiera como en todas partes viven del chantaje y lo ejercen no importa contra quienes ni en qué forma.

Y cuál es el capital de esa compañía? Quién sabe! Ni hace falta ninguno. Por obra del Gobierno fiador con la responsabilidad del país y por gracia de los bonos y de la hipoteca—descontando el crédito que puede no tener don Wenceslao—éste si puede sin un céntimo obtener para su habilidad las ventajosas utilidades que fuera de esta sola transacción, son siempre premio de los efectivos amontonamientos de dinero.

Para sólo el negocio de los bonos constituirían sociedad cualesquiera capitalistas de cualquier parte. Pero sólo la hipoteca de las propiedades harían otros las construcciones de el proyecto. Por la sola exención de derechos por la introducción de materiales se comprometería cualquier sociedad a hacer el más costoso trabajo y con esa sola de las condiciones del con rato habría para que la situación económica del país—lesionada gravemente el Fisco y el Comercio—bajara el peldaño último de la escala de angustias por la que se le viene precipitando.

Dos de nuestros pobres carpinteros mal pagados y mal vistos podrían constituir la misma empresa, y esto con los merecimientos reales de quienes trabajan y con menor ofensa de la moralidad administrativa.

Pero fuera de todo y por sobre todo: qué tiene que ver el gobierno de Costa Rica ó, mejor dicho: qué razón hay para que el pueblo de Costa Rica responda a la Compañía de don Wenceslao por las utilidades que se proponen obtener de su mafia y de su ascendiente sobre el Gobierno?

Transacciones como las que haría la «Whence Lie Co» se verifican en todas partes del mundo directamente

entre los representantes de las Compañías y las personas que a éstas ocupan, sin que los gobiernos tengan que hacer en ello sino cuando un fraude se descubre ó se sospecha una jugada.

Y en cuanto a Costa Rica, bien puede don Wenceslao aprovechar sin pedir las garantías que a toda empresa honesta ofrecen nuestras leyes.

Qué es, pues, lo que a don Wenceslao adeuda Costa Rica para que él ni el gobierno reposen antes de romper las compuertas por donde han de vaciarse sobre las arcas particulares de aquél las arras nacionales que el otro tiene el encargo y el deber de administrar con honradez y con cordura? Por qué es que pasan treinta días sin que una proposición ofensiva para los intereses públicos se conozca en Costa Rica de parte de don Wenceslao de la Guardia, o bien que se proyecte o se cumpla en su beneficio alguna repugnante?

Bien habían don Ricardo y don Manuel de Jesús Jiménez explicándolo de una vez.

## The Height Of Embargo.

We notice in the "Judicial Bulletin" an edict that has filled us with surprise.

At a recent date there was put up for Public Action in San Jose, at the base of 130 colonos, a vault situated at the Cemetery in Exasa. The vault is capable of accomodating 5 corps, two of which is already occupied, and for which the rental for the period of five years has already been paid. It measures approximately 1 1/2 yards in front, 2 1/2 yards in depth, 3 feet in height and is constructed from stones and brick. The tombs are situated, two at the bottom, two in the middle and one on top.

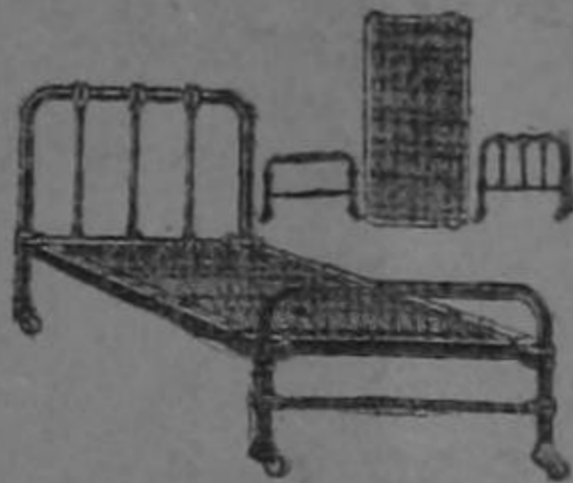
## Prisoner Escape.

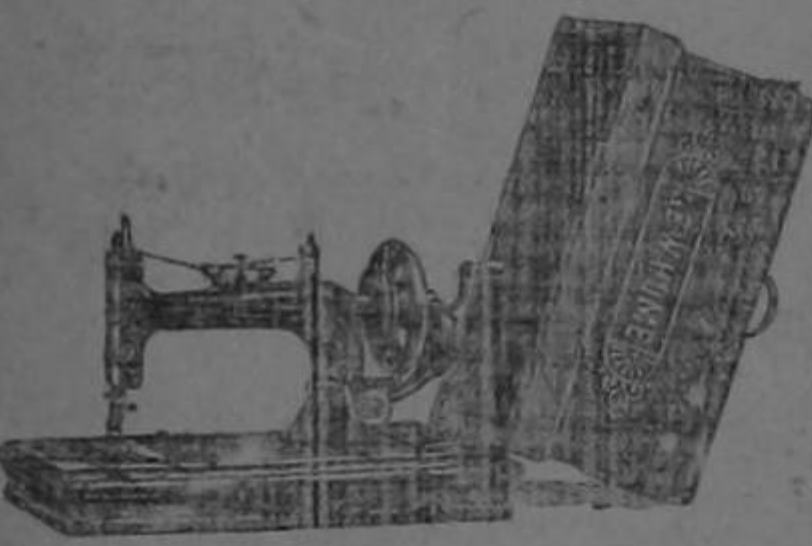

THE REV. TROTT

The Rev. Trott leaves Costa Rica at the end of the month back it is supposed to Corn Island. This gentleman was sent over here some time ago to help in the clerical work of the Parish, but as it is said that the Church cannot support another Minister and especially since it is said that Costa Rica shall not have a coloured Priest to administer to the Spiritual needs of the coloured people he goes where this ruling may probably be not so stringent. This gentleman has been very much appreciated wherever he has been heard, and it is a great regret to Church goers, that he has to go; as they feel that had he been stationed here, he would have assisted immensely to harmonize the present unrest in the minds of the professing Christians in Costa Rica. His presence here would help poor Archdeacon Robinson greatly in his work who has come unfortunately in a time of great disquietude and borne lots of blame which he does not merit. It is a pity he could not suggest sending Mr. Lorde to Corn Island and keep Mr. Trott here, we feel that the prosperity of the Church would mount 100 per cent by the change, and would suggest his proposing it to the Ecclesiastical Lords.

## Railroad

### Inconvenience.

Mr. Editor:

Sir,—Please allow me a little space in your valuable paper to protest against the inconvenience and discomfort prevailing on the Old Line passenger trains.

As every one very well knows, dust, grime and dirt we have with us always, but when it comes to a hundred and more people packed into a railway carriage, jolting, pitching, crushing and rolling against each other, it is too much.

On Saturday, July 20th, such was the condition of things. An accident occurred which would have doubtless occasioned a serious affair. An aged man in the first class compartment was leaning up against a chair as there were no sitting room. The space he occupied was very uncomfortable; by chance at a jolting of the train he rocked and brushed against a white man occupying the chair near him. Urged by his great dislike of the coloured race, and fearing that he may have to go to the pool of Siloam to be washed of the touch of this poor aged black man, he rose and thrust him twice, becoming so angry that he drew his revolver and—well, another man interposed and stopped the shooting affair. Everybody was shocked to see such ignorance displayed by people—alleged white people, who boast of civilization. Does this thoughtless, ignorant white man know what would have happened had he fired into a packed railroad carriage with babies, women and men all crowded around him?

## Shooting At Squirres

On Sunday evening at about 9.30 p.m. Receiver Salvador LaCoya, shot Receiver Gerald McCutchen, both of the United Fruit Coy., at the Receivers quarters in Squirres.

It is said that LaCoya fired at another Receiver and McCutchen jumped up from his bed to find out the cause of the shooting when he received a shot in his abdomen, just about the right lumber region. LaCoya immediately left the quarters and went towards the town where he was arrested.

Dr. Aguilar and the Coy's Dispenser, Mr. C. Aubrey Shaw were immediately called and they rendered what help they could while a special train was got ready to take McCutchen to the Hospital. A great deal of sympathy was expressed by all the employees for the poor wounded man and all helped in one way or another to make him as comfortable as possible under the circumstances. Mr. J. Carnody especially, distinguished himself with his willingness to serve, and too much cannot be said to the credit of Yard Master Skelly and Conductor Woodfall, for the quickness and intelligence exercised in having the special train ready; it beat the record, as near as we can figure, as the

wounded man was on the Chief Surgeon's table in the Hospital in Limon two hours and a half after the shot was fired in Squirres. Mr. Shaw who accompanied Mc to the Hospital returned the same night to Squirres.

It is very commendable to the Coy. to have such a staff of efficient employees who are always ready and anxious to do their best.

We understand that since Receiver LaCoya got wounded in his head on the Squirres bridge a year or so ago, he has often shown signs of periodical madness and there is hardly any doubt that a fit was on when he started shooting. From all that is known, there existed no cause for trouble between him and his brother employees.

## The Compromise

By a Public deed that was presented by Mr. Wetmore, Agent of the Atlantic Fruit and Steamship Coy., the suit against Messrs. Lindo Bros. for three and a half million dollars, has been withdrawn. The Atlantic Fruit Coy. receives 100,000 dollars gold to withdraw the action. Thus has been brought to an end the biggest lawsuit that has ever passed through the Courts of Costa Rica.

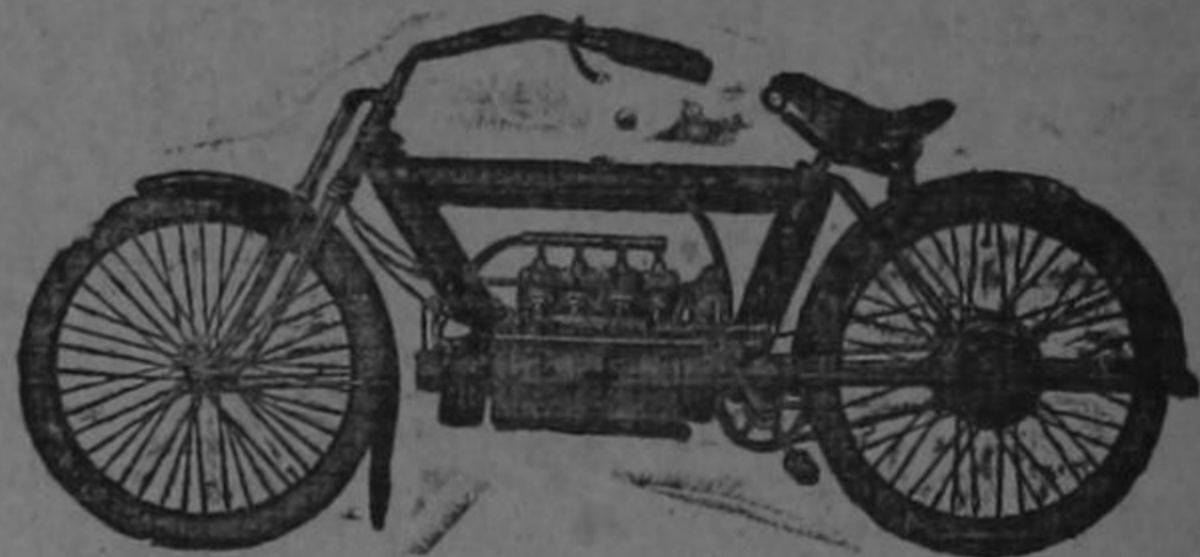
