Obituary.

We have the painful duty of recording the death of Don Manuel Brenes, Administrator of Customs of Limon.

This sad event took place at 10:30 p.m. on Wednesday. The old gentleman had been suffering for several days now from an acute attack of Pneumonia and the doctors did all they could to relieve him, but from the start, they had very little hope especially considering his age. The entire family along with some of his friends left for San José with the corpse by special train on Tuesday morning at 5 o'clock.

The Public Administration has indeed suffered a severe blow by the death of Don Manuel. He has been one of those Public Servants, who did his duty conscientiously up to the letter of the law as far as duty was concerned, he regarded the rich man or the corporation no more than he did the poor man who stood beside him and he always resented harshly any proposition to encourage him to deviate from the regular path. The law was his guide and despite everything else, he insisted that the law said so and so. He was always very mindful of his subordinates and protected them against all comers when they were in the right, but when wrong, he never spared the rod of chastisement. He had his enemies because he was a strict business man, and would not regard any request more than another, no matter by whom; however these are the sort of men we want here in public service. Would to God that we could always find more Don Manuels to be our Governors, Civil and Criminal Judges, Postmasters and Administrators of Customs, we would be certain to have impartial dealings.

The Times begs to extend its sincere sympathy to the bereaved family.

A new Ship.

The s.s. Bencliff, Captain A. S. Hanson of 2210 tons, arrived here on the 31st inst., with 3449 tons of coal for the Northern Railway Coy.

This boat is a novelty to Limon in consequence of her peculiar shape, she is what is called a turret deck ship, so built as to avoid the measurements going through such places as the Suez Canal, where the tolls were chargeable by deck measurements. This is the second boat of her class that has visited Limon. They have ceased building this class of ship within the last few years. There was an accident on board on Wednesday night, one of the workmen got a hit from a coal bucket in the head which bled profusely, but he is not seriously hurt.

Mr. Cauton returned home and is now Minister of Fomento in his native land. We wish the ladies a pleasant stay in Costa Rica.

Italian War.

OFFICIAL REPORT

An official communication referring to the Dardanelles cannonade, says that a flotilla of torpedo boats, "while pursuing the enemy's torpedo boats, or for the purpose of reconnoitering," made a dash into the Dardanelles. Although detected by search lights fired on by the forts on either shore, they pushed on until they discovered the enemy's fleet was protected by steel cable obstructions. They were thus prevented from delivering a attack on the Turkish warships anchored in the strait.

"The Italian flotilla," says the communication, "receded in perfect order despite the heavy fire of the forts reaching the Aegean Sea intact thanks to the enemy's bad gunnery."

Admiral Viale in a wireless report on the raid of the Dardanelles by Italian warships says: "On the night of July 8th, the torpedo boats Spica, Centaur, Astore, Climente, and Perseus crept unseen through the opening to the Dardanelles, but were discovered before they had progressed far inside. Dozens of search lights flashed on the torpedo boats and the Turkish forts opened a hot fire. The flotilla, however, continued to steam on at the rate of 21 knots in close formation, hugging the European shore. When they reached Küldi Behr, the Spica, which was leading, ran into a steel cable. She disengaged herself but soon ran another. The search lights then became so dazzling that it was impossible to steer any course and Commander Mille decided to retire. This was effected in perfect order."

No conocemos a don Manuel L. Al trazarlas, hemos visto atrás, admiramos al hombre activo, al luchador incansable, al probó, al integro ciudadano. Nada podemos esperar de él, que hoy goza el premio merecido y anda lejos, muy lejos, de donde tanto lo incitó a sufrir mezquinas pasiones. Le dejamos sincera estimación, y ya que en vida no pudimos presentarle francamente el testimonio de la nuestra, quedarán estos renglones como un eco débil, pero franco y espontáneo de la pena que embarga nuestro espíritu.

El país ha perdido uno de sus buenos servidores; sus amigos un corazón siempre abierto, su familia... lo ha perdido todo!

Aludimos al señor Cónsul de Costa Rica en Jamaica,

Encargados de la defensa del señor Robert Francis en la causa que en el Juzgado del Crimen de esta ciudad se le sigue por homicidio, dentro del término legal pedimos la prueba ultramarina que fué acordada; y previos todos los requisitos legales se le remitió al expresado Cónsul el respectivo exhorto para su debido cumplimiento; sin que, a pesar de tres meses que han transcurrido, haya cumplido la comisión: la razón ó excusa que expone es: que él es Cónsul ad honorem, que no devenga sueldo; y por consiguiente no cumple lo que se le ordena, de ese modo, si no se le "renumerá" su trabajo.

Por motivos de reproche es práctica entre todos los Gobiernos, tratándose de materia criminal, y conforme á lo que se hayan convenido á este respecto, cumplir las comisiones que anse ellos se hagan, por medio de sus Ministros, Delegados ó Consulados, de manera gratuita, es decir sin ninguna clase de estipulaciones acerca de honorarios.

Si cuando se le pidió el nombramiento, ad honorem, se hubiera fijado que por esta condición lo serviría sin sueldo, antes que aceptarlo para hacer ostentación consular en parte diplomática para satisfacer su vanidad, no ha debido aceptarlo y en tal virtud lo mejor que puede hacer es presentar su renuncia.

Preguntamos: ¿Por qué no lo hace? Porque no es gracia suavemente desempeña ese puesto, en atención á que son muchos los derechos que cobra por derechos de embarque, desembarque etc.

Son valiosas las relaciones mercantiles entre esta República y aquella Isla; y muy grande la colonia jamaicana en esta provincia, por lo cual llamamos la atención al señor Ministro de Relaciones Exteriores para que se remedie el mal nombrando nuevo cónsul con su respectivo sueldo; y así se evitará el acto de descortesía que acaba de hacerse con nuestra Suprema Corte de Justicia quien hizo la remisión y el mismo Ministro, orgullo por el qual se sumió el exhorto.—Limón 2 de agosto de 1912.—E. A Debate.

On Thursday evening Aug. 1st a most enjoyable evening was spent at the rooms of the Limon Literary and Friendly Association, when the Debate which was announced to take place, came off, the topic being: "Is our boasted civilization a failure?"

Mr. S. Paddyfoot led in the affirmative & backed up by Mr. W. S. Alvarenga while Mr. G. E. Robertson answered in the negative, unfortunately Archdeacon Robinson was indisposed and could not attend, hence Mr. F. C. Wynter, 1st President of the Association introduced the speakers and asked the Revd. G. C. Trott to occupy the chair.

Mr. Paddyfoot endeavoured to show that civilization had failed in its mission because it had not brought man to look at his brother man as a brother. Indeed as was evident from the amount of strife and confusion which continually goes on among us, quoted the difference in races, he also cited the warlike preparations for man's destruction, as well as the proficiency in arts and sciences as practiced by the Greeks and Egyptians which he claimed has been unsurpassed by modern artists and which have always been looked upon by the civilized world as treasures of great value. He quoted the perfections in morals and characters as practised among the savages ending up by proving that civilization had brought on more diseases and sickness than were known by the savage.

Mr. Alvarenga strongly backed Mr. Paddyfoot's statements and proved that the methods adopted in tearing away the savage from his home and selling him in foreign markets as slaves tended to help to prove our civilization a failure, for even the barbarian believed in a higher being and at that he was more sincere than we are at present in our religions, he corroborated Mr. Paddyfoot in everything that civilization of today is a failure.

ECHOES OF THE SHOOTING.

Circumstances arise at times which of themselves are such delicacy that one refrains from passing an opinion, but when it comes on a matter of public importance, we feel bound to close our eyes to the sentiments of individual feelings and do our duty to public welfare.

From what we can gather, the evidence that is before the Courts relative to the shooting of Mr. Gerald McCutchan by S. Lacayo, is of such a nature that the accused is expected to be acquitted very soon. Now however much we may feel for the unfortunate young man in custody, and particularly for his family connections, yet we do not feel it is just to the public to set such a man at liberty for some time yet. We feel the British Vice Consul or Consul ought to interest himself in this matter and if our information be correct, he ought to enter a protest in the liberation of this criminal insane. We feel sure that if it was an American subject that was shot, Mr. Donaldson would not so soon have the offending party walking side by side with us in the streets without doing everything possible to have him placed if not in the Penitentiary, in a place made for criminal insane. Apart from considerations for the life of the unfortunate victim, why, for the safety of the public, this man should not be set at liberty on the plea of insanity until he had spent several years in confinement and to the doctor's satisfaction after careful scrutiny that he is perfectly sane.

We hope our Vice Consul will thresh this matter out so as to put a gem to his crown, so when his retirement takes effect, (if ever it does), that we may be able to reflect on the good things he hath done.

Sanitary Disputes.

A peculiar case has come under our view, whereby an Inspector of Hygiene has been embargoed by a Syrian lady in the market because acting under orders of his chief, the doctor, he broke two barrels which he claims were contrary to regulations, not having the necessary wire meshing. These barrels are said to have been reported to the doctor on different occasions and the owners sent down to him, but no fine was apparently inflicted, seeing that owner made no attempts to amend the conditions of the barrels he broke them, hence the lawsuit. His pay has been levied on and the doctor is alleged to have expressed himself as not having anything to do with this. The inspector thinks that the suit should be against the Sanitary Department and not him, he has protested the levy and issued a suit against Senora Luisa Solomon for 90 colones. He now awaits the doctor's evidence. It is said that another inspector without reporting the circumstances to Dr. Cespedes condemned about 300 lbs. beef for Don Carlos Saborio as not

fit for human food and dumped it. The protest of Don Carlos may be well imagined, it is expected this also will come up for hearing in the Courts, whether these officials are responsible, or the Sanitary Department is, for the orders given them, are matters to be solved within a few days.

Opera Co.

The Compañía Infantil Italiana, arrived by special train on Thursday evening and left for Europe by the Italian boat leaving on that day.

From Nicaragua.

We have news from Nicaragua that a revolution has broken out in that country. It is said that Genl. Mena, Minister of War in the present Administration has been arrested in his office by orders of President Diaz in favour of Genl. Emilio Chamorro, both Mena and Chamorro are Candidates for Presidency.

Emperor dead.

Mutsu Hito, Emperor of Japan died at midnight on Monday last in the Imperial Palace at Tokio.

He was 59 years old, being born on 3rd November 1852. He has been the most adored sovereign on earth by his subjects. His son and heir Yutshi Hito has been proclaimed Emperor in his stead.

Kidnapping

Two little girls of good society of 10 and 11 years of age respectively, were stolen from their parents in Cartago and taken to Paraíso.

The perpetrators of the deed has however been caught and lodged in jail, one of the children got away and gave the alarm, hence his capture. The children have been examined and found that they have not suffered any violence. The reason for this act is intriguing the attention of everyone there.

Scriptural Enquiry

Mr. Editor:

—Permit me space in your valuable paper to answer to an enquirer who asks me to prove that the Kingdom of God was not set up at Pentecost. Instead of the Kingdom set up at Pentecost it was the King himself in departing told His disciples that though he would send the holy spirit a few days hence, (which we believe came at Pentecost) in John 16, v. 33 said: "In the world ye shall have tribulation, but be of good cheer I have overcome the world."

Rev. 3, v. 21. Let us then earnestly pray: Thy Kingdom come Thy will be done on Earth as it is in Heaven.

The Commission.

By the Gazette of the 27 July we find the Commission giving their report. The principal items of their report are that Mr. Mullins came to his decision that there was no more than 600 stems of fruit weekly that was not contracted to the U. F. Co. by the fact of his ship, paying \$77,506 stems of fruit in the month of May of which 875,180 were under contract hence there was only a balance of 2326 not under contract, but in June he got 3875 not under contract. Whereas Mr. Mullins said he had promises of fruit from producers having under cultivation 1161 hectares of land hence calculating 10 stems to the hectare he saw he had 11610 stems.

They say several complaints have been lodged against the United Fruit Co. by the farmers for losses in receiving their fruit. They seem to feel also that there has been stolen fruit delivered to the Atlantic Fruit Co.

However, they feel that these tenants occupy lands even though those lands are contracted they are not liable for those contracts except they themselves sign to respect them. The full report will follow in our next.

At the Baptist.

On Thursday evening there was an Emancipation meeting held at the Baptist Mission. The Revs. Pitt and Gaspole assisted the Rev. Ford. They lectured on different Topics relative to Emancipation, but the most amusing incident was when an aged man as Teacher from 12 miles named Lewis asked the our ministers of religion. "If we have say tell us what they have done to help the cause of Emancipation from the time slavery was abolished?" Mr. Ford quietly folded his hands and admitted that they had done nothing, he was asked he said but they had to admit that they had done nothing.


