Failure in Societies Profit by Atlantic's Presence.

Mr. Editor:
Sir,—Permit me a few lines in your valuable columns to express myself, re your efforts. I see that you are endeavouring to put forward for the betterment of the coloured West Indian, who make these foreign parts our temporary home, for the purposes of improving our normal conditions.

Within the past 3 years there have sprung up the following organizations in Bocas del Toro and Panama. The International Trading and Investment Coy. with records of the history of its Executive as black as midnight. The Palmas Union of no appreciable object nor result; The Bocas Industrial and Commercial Benefit Union. Then what could be the Grand West Indian Immigration and protection Club, if properly administered with honesty and integrity, but unfortunately there has been a great deal more said than done of this society.

Basing my knowledge from April 20th 1910 to 1st January 1912 since when from change of residence, I am short of information which was due me up to 31st January, but although I have written its president, but in keeping with the usual grace of this Executive, there is always a difficulty in acknowledging legitimate communications, and of course as I know how very defective the laws and administration were, I submitted my desire to withdraw membership, the fact being that in three chapters consisting of 65 articles no provision is made for the return and report of the business transaction of the West Indian Immigration and Protection Club and during my membership of one year and ten months, there has never been a report worth the name relative to revenue and expenditure under their several legitimate heads.

Members are supposed to be registered as British Subjects at the Consulate and a 60 cents gold was collected in addition to entrance fee and monthly contributions whereas for the whole period of one year and ten months under review, there has not been the registration of a single member to my knowledge.

The majority of the members live and work in the interior on the lagoons and can get no information whatever except what might be supplied to them, through these Reports, besides they are members of what is said to be an Incorporated Trading Society which raises Capital by shares of 5 dollars gold each, which provides for a half yearly report, yet up to the 1st January last, there has not been any report worthy of the name. The greatest ground for apprehension however, is to know that this Company is not registered in accordance with the conformity of law, hence it is not in a line with

progressive business methods of today, and bearing in mind the results of former organizations, which have been started with similar aims as this, such as The International Trading and Investment Coy., The Palmas Union, The Limon Artisans and Labourers Union, the Kingston Daily News, The members of the West Indian Immigration Co-operative & Trading of Co. Bocas del Toro and any such Club or Organization formed in Costa Rica for similar aims should insist that their leaders be men of unquestionable integrity and see that their Society be properly registered, so that if the Executive do not act faithfully in their duties, there may be a means of bringing them to justice.

Current Prices Of Foodstuffs

Sugar has dropped 4 colones per quintal, from 22 colones it is now 18 due to the recent importation from Jamaica and Cuba. Corn also has dropped from 60 colones to 40 colones per fanega. This same time last year it was 26 colones.

Beans also has come down from 60 colones to 40 colones, there is a very heavy crop. There is no rice. Dulce has dropped considerably, the speculators have lost fearfully by the fluctuations from the recent importations.

There is a very short crop of coffee and cacao coming on the price of cacao in San José is 26 colones but with the shortness of the crop it is bound to rise if producers will only hold it a little.

There are two monopolies formed in San José, one for Soap and the other for Vermicelli, consequently these prices have been advanced.

Attention Widowers.

By observations in and around the Park, we cannot but say that one of our distinguished widows has eclipsed the girls of her own make up, and from what we can gather there will soon be another wedding.

At the grand ovation given to Mr. Cecil Lindo at his arrival here as the forerunner of the Atlantic Fruit Coy., it was said that he was to have built a Hotel in San José for Tourists to cost half a million dollars, but we find now that this seem to devolve on the shoulders of the U. F. Coy., for we learn that this Coy. has bought a spot of land from Don Rafael Yglesias in Cuesta de Moras on which it is intended to build a Hotel to cost that amount.

This Club has removed into their former premises known as Solomon's Temple, the property of Don Quinto Vaglio which was burnt down in the last fire, but is now beautifully rebuilt by its energetic owner Don Quinto.

More Discount On Labour.

Mr. Editor: Sir,—Please permit me through the columns of your valuable paper to reply to an article which came out in your issue of the 22nd inst., under the heading "Re Lindo's Pay Day."

The writer referred to an article in the issue of 12th inst., headed "To be or not to be," and tried to disprove the fact laid down in said article. He finds no discontentment among the labourers on Messrs. Lindo Bros. farms. He finds the labourers to be very much satisfied with the treatment given them by the system adapted by this farm. He finds them to be dissatisfied about the foolishness of attempting to pay them twice monthly. He even goes to show that Limon would suffer by it.

Now, the writer cannot be sincere. He seemed to be greatly interested in the concern of Lindo Bros., and aimed to deceive the public.

The law demanded two weeks pay. "Mr. Commercial Traveller" calls it foolishness. Intelligent labourers prefer two weeks pay. It would be better on all sides; a regular two weeks pay would be a help to the people and the country. Limon would not suffer, but benefitted, even Cartago would rejoice and San José would clap her hands for joy.

The flood of money which rolled down the coast of the Isthmus of Panama in the time of the French Canal, took its rise from a regular two weeks pay. To state that the orders are accepted anywhere is foreign to the truth.

First, the order is issued from the farm to an establishment where one received a kind of paper ticket with the sign and figures of "El portador tiene credito en nuestros. Esta constancia no es negociable." And

OUR WATER SERVICE.

Our water service for the past week has been in an awful condition, when it is not locked off altogether from us, the condition is such as to make it unserviceable. El ex-Presidente Roosevelt sin careta

Abusos de confianza

A la función que dió ese circo el sábado próximo pasado concurre uno de nuestros empleados, y en momento en que entregaba su tiquete, observó con sorpresa, que el Sr. Andrés Lery, hacía uso del nombre de nuestro periódico para penetrar al circo, haciéndose llamar director de la parte castellana.

Como saben nuestros lectores, el señor Lery estuvo manejando la sección castellana, la que dejó el día catorce de setiembre del año en curso, y pasó a cargo del Procurador Judicial don Enrique Giménez Dávila.

Carta de lamentos

Con este epígrafe publica un artículo «El Alfiler» periódico editado en Sonsonate, El Salvador, correspondiente al 30 de Junio del año en curso, en el que se comenta una carta que un buen conservador dirige al director de «El Centroamericano» con motivo de haber publicado ese periódico un ataque injusto a los hombres que manejan en esa época los destinos de nuestra querida patria, Nicaragua, y a los que también se habían retirado a la vida privada, como el magnánimo Gral. Emiliano Chamorro.

He aquí un párrafo de la carta citada y los comentarios que hace «El Alfiler».

«Bien se me alcanza que esos ataques son de cierto liberal panterista nicaragüense, que no le perdona el pecado al General Chamorro de haber sacado del Campo de Marte con la punta de su espada vencedora al toro montañés de campuzano, al César de cocina, etc. etc.»

He aquí los comentarios.

«No es vencedora la espada del General Chamorro, puesto que fué derrotada en El Colorado, Matagalpa, Tisma y Tipitapa. Después de estas dos últimas derrotas en las que dejó todos los elementos de guerra, con fuerzas superiores a las del Gobierno quedó incapacitada la revolución en el interior de Nicaragua.»

No teniendo conocimiento, si el autor de dicha carta supo con testar como es merecido, los comentarios que hace de ella, «El Alfiler» tratando de desvirtuar la flameante espada del Jefe del Partido Conservador nicaragüense me tomo el cargo de contestarlos para que no pasen sin protesta alguna.

El General Chamorro fué vencido en Tisma y Tipitapa después de haber reventado el últi-

mo cartucho y por fuerzas superiores a las de él, y no dejó como dicen en poder del ejército legitimista todos los elementos de guerra.

Así es pues, que la derrota de Tisma y Tipitapa, las sufrió con honra el General Chamorro por que dió a conocer una vez más el brillo de su espada.

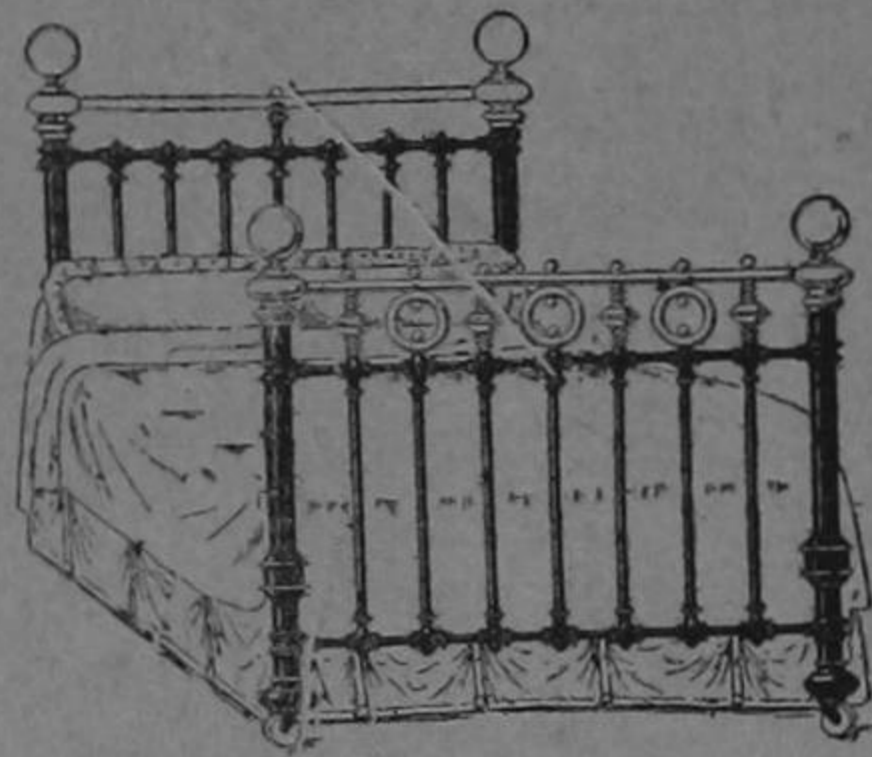
