## Recent arrest In England

London, Dec. 21.—The British naval authorities have been considerably perturbed of late over the way in which minor secrets of British ships have been reaching foreign powers, and particularly Germany, the spies from which country, it is asserted, are always prepared with the biggest prices for anything pertaining to naval matters. There have been several prosecutions of civilians charged with communicating these secrets to foreign powers, and one or two men under suspicion have been dropped from the navy. More importance is attached to the recent arrest of George C. Parrott, an ex-gunner of the navy, one of the class of petty officers who, under recent regulations, are in line of promotion to the commissioned ranks.

Parrot it was found, while doing duty at the school of gunnery, made trips to Ostend where, according to evidence given against him, he was met by a foreigner, with whom he spent the evening, returning to England the same night. As it is against the regulations for a bluejacket or petty officer to leave England without leave, Parrott's name was removed from the navy list, and some months later, the police having discovered that he received letters from the continent with money enclosed under an assumed name, he was arrested. It was also found that Parrott had deposited considerable sums of money at his bank. One of the points of evidence against the prisoner is that the bank notes he received on one occasion or another had been sent to Germany. This evidence was made possible by the fact that at all banks a memorandum is made of the numbers of Bank of England notes in the bank's possession, and the disposition made of them. In this case two of the notes had been paid out to travellers, who had changed them in Germany.

## Rigid Treatment.

It is understood that the policemen are tendering their resignation daily, on account of small wages, bad clothing and arbitrary measures extended to them. We hope the Governor will rectify this matter as at least our police ought to be better clothed, so as to appear smart and tidy in the Country.

## Snow Storm.

A passenger that arrived on the s.s. Sigismund, reports that on account of the intense coldness in New York city, several persons were forced to leave for tropical climes. The snow measures 3 inches which at times caused the suspense of traffic.

## Death of a Princess

Rome Dec. 28.—The Court of Cassation has confirmed the life imprisonment sentence of Lieut. Baron Vincenzo Paterno, who murdered his mistress, the Princess Trigona, lady in waiting to the Queen on March 2, 1911. This was one of the most tragic crimes of passion ever known here.

## Labour Strike.

The U. F. Coy. has been experiencing trouble in Barmouth Farm. The labourers have struck work for higher wages, and were determined to be riotous, starting to chop up whatever came in their way. A squad of armed police had to be sent out to quell the trouble. The men were all paid off and dismissed immediately from the farm.



One could not understand what that meant, whether it was from craziness, ignorance or drunkenness, however no attention was paid, thus avoiding a serious conflict in the office.

These examples of gross insolence are practiced both by the Bosses and messengers.

Are the public to stand this discourtesy from the employees of this Coy., who if it were not for the travelling public would possibly have no jobs. This messenger in question a true semblance of Darwin's theory forgets his true position in an office to the public when on business. It is a pity that the Great Bismarck does not see to this and get cultured boys as messengers and not those belonging to petty coal launces in Jamaica.

OUR LABOUR UNREST.

The labour unrest seem to be occupying the minds of capitalists the world over. If we observe the foreign papers from day to day, there is evidenced an awful disquietude on the part of the labouring population of almost every country. We see not only the male section of the communities, but the women have also taken up the cudgel and in the dress making, millinery and other factories, we find them banded together in hundreds of thousands, demanding better conditions for working and higher wages for their labour, and here in Costa Rica, conditions are no better; in fact matters seem to be worse than in most places, the feeling of unrest seem to be as much manifested as anywhere else, but for one reason or another the initiative cannot be made whereby demands may be set forth for ameliorating the present state of oppression.

There is at present an awful tide of dissatisfaction among the labouring classes throughout the entire section of the country affected by the labour fields of the United Fruit Coy. and Northern Railway.

The labourers seem to have an antipathy for the Leads of Department in consequence of the stringency of the present Administration, yet for want of unity they are unable to come together and hold together in demanding a better state of affairs.

We give an idea of one type of the unfair means handed out to these labourers: The coal boat of last week got discharged of her cargo on Thursday last; as a rule these men are always paid off the evening the boat is finished discharging or at least next morning. This time the men were not paid until Saturday evening. The s.s. Piaz Sigismund, The Wm. Cliff, and Tivives, all ran in harbour on Friday morning for discharging, and requiring 3 gangs each ashore for receiving the cargo. The Tivives of the U. F. Coy was supplied all the men necessary for discharging, meantime the Sigismund of the H. A. Coy. has to supply the Railway Coy. with her men from aboard to receive the cargo, and the William Cliff of the Leyland line cannot be discharged for want of men. The Agents are told that the men who were working on the coal boat are tired, whereas if the men were paid off on Thursday evening or Friday morning they would all have been willing to return to work, rather than sulkily idle away their time waiting and watching for the pay time meantime in the Capt. Owen and his assistants are annoyed and assailed in every direction with queries and compliments, due to the distressing, red tape system put in force by the present Administration. On other occasions, if there happens to be a holiday on at pay time; very often the pay card comes and the money is shown them, but payment refused until a day or two after perhaps with the idea that they should learn to economize.

These are the actions which help to cause the tension now evidenced between the labourers and the Coy.

In another column will be read the existence of a strike at Barmouth, this is the second strike in that district within the last four months, which is evidenced of the fact that if these men are given the sympathy of

their co-workers, they may be the nucleus for the formation of a society, be it Union or otherwise that may help to bring forward a better state of affairs, and so bring themselves in the line of operations existing in other countries.

We learn that the men brought from the other farms to do the work of those on strike also refused to work, this is glorious news, if our men would begin to learn to hold together in this manner in a decent law abiding demeanour, matters would soon be made right.

There have been several attempts here, and natives have been brought down to do the work, but how long have they ever remained, and if our men would only stick together, particularly now that labour unions and clubs are being formed in the Interior there is no reason why better wages should not be paid.

The Commerce of the country is paralyzed in consequence of the low rate of wages and the scarcity of work; for this reason thousands of our men have left it, hence there is no reason why our men make a stand and keep to it determinedly that they should not better their conditions, and that of those around them. The sympathy of the entire Community is with them due to the oppressive Adminis-

tration under which they suffer and if they stick together for a month, the business of the Coy. cannot be delayed for so long a time, and from Mr. Laws' experience, we hardly think there will be many more volunteer missionaries. We will return to this article.

New Motor Car.


