Failure of Lodges GOOD NEWS

There have sprung up in and around Limon, so many Lodges that apparently the people seem unable to meet the obligations placed on them, and as for the most part there seem no real unity among them, but rather jealousy, the fact comes that they are called upon to face greater expenses than they would have had to face, were there a better understanding between them. Some time ago two Lodges implements were levied on for rent, and now four others have suffered in a similar degree.

The Mosaic Tempairs which embraces three lodges namely: The Rose of Sharon Chamber, The Joshua Temple, and The Excelsior Temple, organized by Mr. John Ivey as representative of the Mosaic Templars of North America. The Pearl of Bethlehem Lodge of the Order of the Star of Bethlehem of which Mr. A. A. Archer is representative, occupied a house belonging to Mr. J. C. Wilson, but being unable to pay the rental now for several months, the owner found himself obliged to embargo on their goods and chattels and close the door. Since the embargo has been made it turns out that the Bethlehemites owe no rent, but finding that the other three failed from coming up to their obligations, went to Mr. Wilson and paid theirs, hence their goods may be released; but in the meantime they are bound to suffer the inconveniences consequent on the embargo.

An interesting incident is that Mr. Francis of Camp One, along with Mr. DePass of the Syndicate, also suffer in the transaction; both being interested in an organ which one sold to the other on the installment plan, while the second party loaned same to the Rose of Sharon Chamber.

A beautiful tableau was presented before the Lodge room on Friday evening last, when there was the Maharajah, mounted in the centre of Mr. John Ivey, Mr. Archer, Mr. DePass and Mr. Perkins, who all stood looking at the sealed door in a hopeless thought of getting the organ in question.






