Mrs. Patricia Street, an Australian, will direct proceedings and Miss Ines Millallen will lead the procession on horseback, the dresses and colours to be worn will be many, the first line will wear the national colours of the 4 countries that have given women the right to vote, Norway, Finland, New Zealand and Australia. The second column will wear the colours of the countries that has given partial vote, Sweden, Denmark, Ireland, Great Britain, Austria and Belgium then the concourse of suffragettes and lastly the men who have given their sympathy to the movement headed by Congressman Hobson of Alabama.

From Birmingham comes the news that the Suffragettes have thrown explosives into the office of the Inspector General of Revenue causing a great explosion and fire.

## A Samaritan Explains.

Mr Editor:

Sir.—Permit me space in your valuable columns to explain the misleading statement of the Western District No. 20 as appeared under the heading "Proclamation" in your last issue.

Messrs. W. Toby and Vincent, heroically managed to rescue the body by forming a chain of men holding each others hands with the banana gang at their disposal, as the Indians cross a river. Every thing was done to revive respiration, but to no purpose, as the skull was fractured.

The body was taken to Siquirres by them and the Yardmaster, Mr. Skelly in his usual kind manner replaced it on another train and conveyed it back home to La Junta, after the Doctor had pronounced the verdict of his examination and handed to his friends for burial.



The Judge has declared that General Cipriano Castro, ex President of Venezuela, is free to visit the United States, provided he conducts himself well. Castro as will be remembered was refused admission to the States by the Immigration Department and was kept confined at Ellis Island pending further arrangements, but he applied for his freedom under the Habeas Corpus Act, and has obtained his rights of liberty.

**Rose Hill Lots.**

The Squirres sporting men are to have possibly their last race meeting on the present course, 25th of March, because Mr. Lorig has now got an Engineer making the necessary cross section for laying out the settlements to be made there. The plan shows a township of about 15 squares or manzanas, and the race course is entirely taken up; hence if races are to be run for Xmas, a new course will have to be laid out which is the idea we understand by consent of the owners, Messrs. Lindo and Lorig, to put the course lower down where a beautiful circle course can be had, superior even to the present one.

**Cricket**

The Matina C. C met on their grounds the 28 Miles C. C. yesterday. The visitors won the toss but sent their host to bat, who knocked up 64 runs. S. Hudson topping the list with 18. The visitors then went to bat and the first four wickets put up 44 runs, when there was the usual contention, a ball was hit to the boundry and the Matina Umpire registered 6 runs, whereupon the Captain of the Matina C. C. protested it should only be 4 but the Umpire said the Captain himself made the boundry as 6 and it must be 6.

Mr. Hudson then refused to play any more if 6 was given for it after a delay of nearly an hour, they agreed to let it go for 4 runs, but the man who we thought would have calmed the situation as an intelligent man set the greater fire. The 28 Miles C. C. continued playing but here the Matina C. C. who had put on Grant to bowl and from whom the boundry was hit on his first delivery, coolly took him off, because they saw his bowling was likely to cost them the game without his finishing the other 5 balls to come.

This ofcourse cost the 28 Miles C. C. the game, as the succeeding bowler took them down one by one the remaining 7 wickets only putting on 11 runs, hence they lost the game by 9 runs on the first innings. For the first time the discord was not due to the Umpire, but to a leading member of the Club.

**Cables**

Berlin, 15.—Doctor Falcked Consul General of Germany in Barcelona, has been for the similar position in New York.

London.—Turkey will soon present to the Powers another request for intervention in such terms as will render it compulsory for the Powers to pay attention to the call. Up to now a mysterious silence over the Balkan war reigns.

The authorities there continue retaining all notices, there is rumour of heavy fighting at Chornia, all that is known is that the Bulgarians continue retreating from Icatolja.

From Adrianopolis there is no news whatever. Mysterious silence also reigns in regards to Gallipoli. It is probable that the Turks will land troops on the North Coast of the Sea of Marmara.

**Heavy Claims**

New York, Feb. 12.—Claims aggregating \$8,027,374 for loss of life, property and for personal injuries sustained in the Titanic disaster last April, have been filed against the White Star Line, owners of the ill-fated steamship.

Yesterday was the last day on which claims could be filed under a ruling of the Admiralty Branch of Federal District Court unless an application to the United States Circuit Court of Appeals is granted extending the time. In the event of the limitations of liability being granted, the claimants will only be entitled to a pro rata share in the fund of 96,000 dollars turned over to the Admiralty Court for the salvage on lifeboats. In all 369 claims were filed.

**THE MOIN ROAD.**

Limon is truly a locality of queer doings. Some time ago when our ex-Governor, Don Rogelio E. Pardo administered the government here, he made propositions for putting through the road to Moin, and to carry out this project, he set out preparing the first stage to the Cemetery by the continuation of 1st Avenue, and all was evidently prepared in spite of an objection put in by the Railroad Coy. which we understood was afterwards amicably settled, inasmuch that estimates were asked for and one gentleman sent in an offer for 15,000 colones. Since however, the new Governor and new Municipality have taken over the reins of government, the course seem to be altered, and now Avenue 2nd is the one which is to be lengthened to the Cemetery, but in doing so, the damages that seem apparently being heaped on the shoulders of the Beard will exhaust the allotment for the construction of the road.

The mode however being applied in the construction seem pretty exorbitant, for whereas the road bed is only required to be 20 feet wide, they have cut in some places about 100 feet wide of right away all through some of the best cacao farms in the vicinity and all this seem to be done without the slightest amount of courtesy to the Agriculturists affected by this outrage. In some places the labourers of the Municipality have just passed through the cultivations cutting down the wirefencings enclosing their farms, letting loose their animals, cutting up the vegetables which would be in perfection in a few weeks—hence, without the slightest notice to the poor people and that in spite of the entreaties of the farmers to wait for a couple weeks until their vegetables came to perfection, as the road would not be constructed for possibly a year yet, but all to no purpose.

Worse of all, representation has been made to the Municipality for payment of these damages, but all the response has been to present their titles for these places, knowing full well that most of these people have no titles being in the Maritime limit.

It seems unfair to deprive them of the means of their livelihood and do not recompense them for it, because they have no title. They have been cultivating these places for 15 and 20 years and settled down their families, and if now they are to be disposed of them they ought to be paid off as the law prescribed, so that they can look about starting somewhere else. If therefore behoves the Government to settle these claims without any unreasonable waste of time as is going now. The whole project seem illadvised, as this road will cost fully six times the amount of the other, and it will never be a road; in consequence of the deep ravines and hills to pass over, it will forever give trouble and render that road at times impassible to pedestrians, let alone vehicles, by slides and washouts.



I. Jockey Club Rule will be strictly adhered to.

II. The above Races will be run on the Rose Hill Race Track on the 24th and 25th March 1913.

III. Should a Jockey be found jostling or riding foul, will on the decision of the Stewards forfeit his race and be disqualified.

IV. All disputes to be settled by the Stewards

V. All entries must be in the hands of the Secretary not later than March 16th.

VI. Colours must be declared on day of entry.

VII. The first bugle sounds at 12 30 p.m. First race at 1 p.m. sharp and half hour will be allowed between each race.

VIII. No Jockey will be allowed to sit under 85 pounds.

IX. Any owner of two horses in any race must declare the winner to the Judge before starting.

X. In all protest both parties will lodge Ten Colones. The party decided against defrays expenses of the protest. Protest must be lodged within half an hour after the race.

XI. Judge's decision is final.

XII. The committee has the right to reduce the amount of the purses if necessary

XIII. Ten per. cent will be deducted from each purse to defray expenses.
