Cables.

A cable from Baltimore on the 7th inst., says that the British ship Alum China, laden with dynamite for the Panama Canal was somehow blown up by an explosion of 300 tons of this explosive. 50 lives were lost and several persons wounded, the explosion damaged a great many buildings in the city and the shock was felt for miles around. All shipping near by was damaged.

Havana, 8.—Six thousand rifles and thirty thousand rounds of cartridges were bought in Franksonville presumably for Castro, whose visit is said to have bearing on the movements in Venezuela.

Puerto Plata, 8.—Archbishop Noel, the provisional President has fled to Europe.

It is said that there is a triple Alliance between Venezuela Colombia and Nicaragua for the purposes of keeping Castro out of Venezuela.

Dock Wrecked.

Honolulu, H. T., Feb. 10.—The collapse of the Pearl Harbour dry dock was caused by the upheaval of the soft substrata, in the opinion of Ernest B. Gayler, civil engineer, U. S. N., who talked with divers after their examination of the caisson which gave way. He likens the soil conditions to those which brought about the earth slides in the Panama Canal recently.

Mr. Gayler says that the dock will be completed undoubtedly on the present site, although the work has been delayed years by the accident of yesterday. The Tremy system will be used in the reconstruction.

Rear Admiral W. C. Dowles, commandant of the naval station, and Rear Admiral Charles B. T. Moore, who is to be commandant, have inspected the dock and are sending encouraging reports to the Navy Department. The contractor is sanguine.

Australian Improvements

The South Australian Parliament has recently passed a loan Bill for the expenditure of twenty nine million dollars for carrying out various works—Railway improvements and construction alone will be twelve millions, harbour improvements two millions six hundred thousand, water works four millions, draining irrigations and reclaiming of swamps one and a half millions, and the balance will be devoted, among Public buildings and other such works.

The White Star liner Ceramic recently launched is the largest steamer, yet built for the Australian trade, in consequence of this the Sydney Commissioners have had to widen and deepen the berth for this boat to 35 feet so as to admit her under full load, drawing then 34 feet six inches.

The Maryland Steel Coy. is completing four new steamers for the American Hawaiian Line, the s.s. Montanan, Pennsylvania, Panama and Ohioan, when these boats are completed this line will be the largest afloat under the American flag in point of tonnage, numbers and equipment.

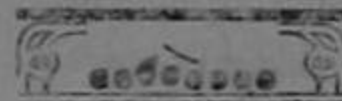

THE EMPLOYEES OF A CORPORATION LOANING MONEY AT 30 PER CENT!

Mr. Editor:
 Sir,—From observations I have been noticing lots of things, though not a detective, and as the world seem yet to shut their eyes to it, I venture to crave your indulgence to ask a few questions, because while I have noticed that the poor labouring man has been watched and oppressed by a paid watchman of the Corporation, I have seen lots of things being permitted to some of those in power, as officials of the Corporation.

It appears that a certain Department of the Northern Railway shops is being transformed into a huge money lending and merchandize Depot.

Does Mr. Mullins who lives on the premises not know that money is being loaned on the premises at 30 per cent? Has Mr. Mullins ever signed orders to permit that certain men's pay be drawn at the Car by a certain Foreman? Does Mr. Mullins know that a man named Thomas Constable, borrowed 100 colones and was given a job as carpenter, meantime he did not know to drive a nail straight being a policeman at home, and left for Jamaica without paying it up? and was a portion of his money which he left behind him drawn by Mr. Mullins' consent at the Pay Car by the person or persons so loaning?

Did Mr. Mullins ever O.K. an order so as to permit A. Lindsay to draw the salary of one Taylor who left the service so as to facilitate a Foreman to draw 5 colones loaned Taylor plus 1 colone 50 cents for interest for two weeks?

Has the Boss Painter Blackman ever been and is being utilized for collecting amounts loaned his foreman around town at all hours of day while he is supposed to have been doing Company's work? Has Mr. Mullins never met him on the streets? Has a man named Lindsay been discharged under the grounds of insubordination, but in reality because he refused to respect a cabinet maker named Trench and denied a participation in the money lending scheme? Has the Detective Inspector in the brilliancy of his operations ever visited Pullar and if so has he never seen furniture being made by a Cabinet maker out of pure Cedar, and has it ever occurred to him that cedar planks are not sold in Limon? Did it never dawn to him that that Cabinet maker was to be seen at times in the company's workshops?

Has he never seen cedar lumber laying carelessly in the Company's cars around the coal pit? and does he know why those cars were switched there and if any of that Cedar was taken out and by whom?

Has the consumption of Cedar for patters, coach repairs etc., never appeared exorbitant to Mr. Mullins? has he ever checked the requisitions in this respect as compared with the work stipulated?

Has Mr. Mullins ever checked the system of how piece-work in car repairing is transferred into day work and vice versa? Is he aware of the system? Is he conversant with the manipulation. Is it a profitable one to the Coy?

Our Postal Service

Our Postal Department makes rules sometimes that are only known to themselves and which inconveniences the public to a great measure.

Sometimes it is that you must not put on your stamps at a certain spot, at other times you must write across the envelope and so on.

A letter was sent by us for Registration on Tuesday, and because the word 'certificado' was written across the envelope, it was returned to us, which meant of course that we lost the mail, but the Post Office lost the 25 cents because we bought a snuff and forwarded it rather than a humbug around Registration. These are the treatments which create more losses to the Department than may be imagined, because one runs the risk of begging any one to take a letter rather than go the Post office to be delayed. The Courier on the Badana River train takes letters and papers when he feels like it, and not when he is late and annoyed, consequently our subscribers have had to stop their supply rather than be disappointed sometimes.

We hope Mr. Castro will try to rectify these errors, as he has always shown a disposition to facilitate the public.

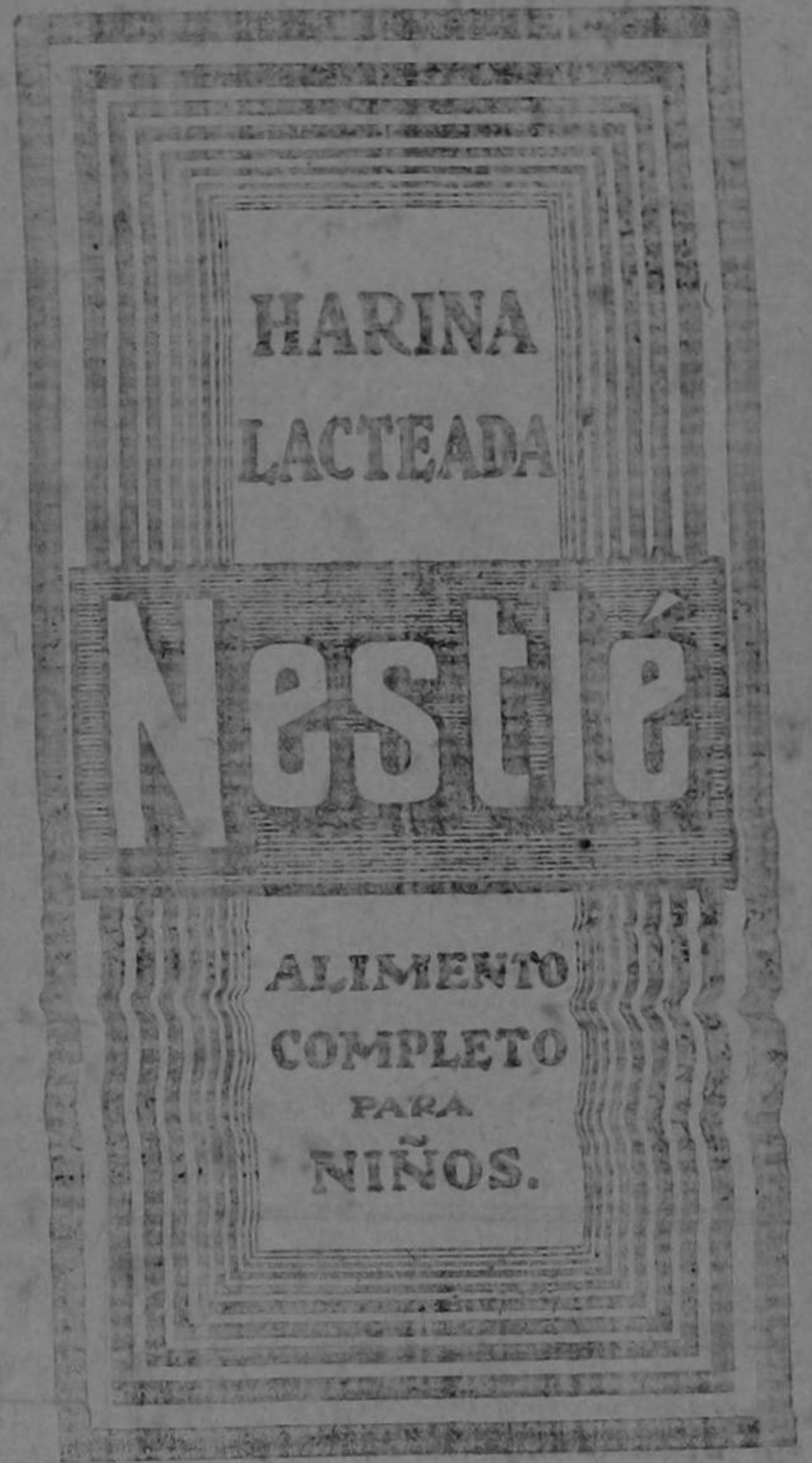
