EDITORIAL

In endeavouring to come before our readers again after a pause of just two months from causes with which our patrons are fully conversant, we are not actuated from any motives of bitterness or revenge towards the perpetrators of the actions ending up to our momentary suspension, but rather, from an idea of fulfilling a want that exists seriously in our midst, and in making this effort it is our hope that our patrons will do all in their power to rally around us, and help to make this Weekly as interesting and beneficial to all parties concerned as possibly it can be.

The aims of this Weckly shall be as it has eyer been to bring forcibly before the public view all matters that may need correction to safeguard the interests of the public at large.

There is no gainsaying the fact that an English journal is an absolute necessity in this Province, which consists mainly of foreigners who if it does not belong to them, have all adopted to a greater or lesser degree the English language, whom even th'o they may be able to understand the much esteemed journals of the country yet there are always articles of peculiar interest to us as foreigners that may not be interesting to the Spanish Correspondents. We therefore have endeavoured and are still endeavouring to fill the vacant spot, by upholding the rights and privileges of an English speaking instrument thro' which those so desiring can always air their opinions and seek an amelioration of the wrongs and grievances to which they may be subject to, possibly not from evil intentions, but from a source of a misunderstanding of our habits and customs.

Within the past 8 weeks absence of the Times, expressions have been very frequent as to extent in which its loss has been feltand we have been approached by all classes of the community to endeavour to make it possible to start up the little journal once more. For these reasons therefore do we make this humble effort, with no intention of bringing harm to any particular individual, but to defend in every way possible with the cooperation of our patrons high and low, every thing that will tend to the prosperity of our Province and the well-being of the inhabitants thereof.

The Nicaragua Canal

It is well known that the United States is encountering more difficulties with the Panama Canal than she had contemplated, and it is evident she fears more yet, in consequence of which she has now entered into agreement with the Government of Nicaragua for the construction of the Nicaragua Canal by way of The San Juan River and the Great Lake of Nicaragua, or any other route in Nicaraguan territory that may be found convenient, which rights are ceded to the American Government in perpetuity, forthesum of three millions of the dollars U. S. currency. To facilitate the proper handling of the Canal route, Nicaragua also leases to the United States, Great & Little Corn Island, for ninety-nine years, as well as a site in Gulf Fonseca to be used as a Naval base for a similar term of years. The money to be deposited by the United States Government in a banking Corporation to be named by the Secretary of States, within a year after this agreement has been ratified; such money must be used for public works, constructions, or anything to enchance the prosperity of Nicaragua | Port Limon - P.O. Box 197 | in a precarious condition.

which will be decided by both countries. This contract will be known as the Chamorro-Weitzell Contract.

The government of Costa Rica has however made a protest to the agreement, from the fact by treaty made between Nicaragua and Costa Rica on 15th April, 1858, on the limits of both countries the River San Juan forms the boundary between them, aud Art. VIII provides that Nicaragua cannot make any connections thereto for the purposes of canalization without first getting the opinion of Costa Rica, and as President Cleveland decided on 22 March, 1888, when the boundary dispute was submitted to him for Arbitration, he said that inasmuch as Costa Rica could not be a party to any such contracts yet where such construction might be prejudicial to Costa Rica, the clause implied a little more than being merely consultory, by which she could also ask pecuniary compensation. The attitude of both governments is therefore eagerly watched by Costa Ricans.

Wharf Improvements

The extension being added to the National is being rushed ahead in a marvelous manner, Mr. Dick Schutt, the old veteran Bridge Constructor of the Northern Railway, assisted by the other old veteran, Mr. Charles Beckles, are pushing along the work with all the accustomed energy for which they are famed. These piles are sixty feet long and as the depth of water is now 33 ft. it will be seen that these piles are being driven nearly twenty feet in the soil. In a couple month's time it is expected that two large boats will be able to draw alongside where formerly only one could be got.

The Company is also doing extensive repairs on the Metallic Pier, so as to facilitate shipping in every way possible.

The Prospects of our Banana growers

gloomy it is the outlook for our banana cultivators in Costa Rica. Except some amalgamatiou scheme is got up among our farmers to protect their own interests and that speedily, it looks as tho' ruin stares them boldly in the face. Those who have scanned around the country must have realized that the Banana disease is making rapid strides in every district, and except special attention is paid personally by the owners or mandadors to the plantations, there will soon be no bananas whatever. The question to us appears that a mandador ought to be paid by the results of his farm, and not by his birth-place or fair looks; we Know of farms in which by persistent efforts the disease has well been Kept in Check.

It is not from disease alone hawever that our farmers are suffering, but more so from need of the doctor; it will be remembered that while the Atlantic Fruit Company was here, the disease vanished, but nowadaysif a bunch of bananas is brought out and happens to show the fingers on the side which faces the rising sun a litlle higher in colour than the other side, it is dumped as diseased. There is no denying the fact the Coy. is simply taking the fruit now as they feel a mind

For the most time one full fruit cuting is given for the week and at that the fruit are either dumped for too full, or bruised, while it is evident that no farmer can live on one cutting per week.

This is the point however that calls our apprehensión. What arrests attention most is the rush in unlimited new plantations on the South eastern side of the Republic that forces us to think, months from what we have seen there has been planted and laid ont about 1300 hectareas in the Estrella division, and in a short

on the borders of Panama. Orders have also been given on the old lines to plant several thousands hectareas of inmune bana-If there is any thing that looks | nas, throughout all the old plantations. Now to those of us who have followed the Policy of the U.F. Coy. in other countries, we feel it is the desire of the Company to purchase fruit here as they have done in Bocas del Toro. That is, when it is needed.

> The time has therefore arrived when "to the observant eye" it must be evident that an Agricultural Association is highly requisite for the protection of the private growers; this Association need not be offensive but purely defensive, and we should suggest that representatives from the Company be asked to attend every meeting, so that no wrong impressions be formed.

Every farmer small or great should be a member of such Association, the idea of which should be to endearour to promote the greater ontput of fruit, by cooperating witch each other in the best methods of its cultivation, as well as to control in ever so small a way the price of this article, by placing themselves in a position to invite competition, or to make shipments when ex-

pedient.

In our opinion, judging from surrounding circustamnees and from the present activity of the Company, which will tend later on to place them in a position to control the amount needed for her ships, we are afraid there will be no more contracts issued in 1915 except they be on less favourable terms to the individual grower. Let us hope that we are premature but this is our humble opinion hence we sound a warning note, to open the eyes of our big planters.

He could not therefore hold out any hopes as to the time when the Company would start, especially in view of the stage at which the litigation between both companys had arrived. He stayed in Limon for two days and proceeded by the some boat to Pearl Lagoon. Mr. Van Scriber's family left with the same boat for the same port, Mr. H. Castro & Bro. the lawyer of the Atlantic Fruit Coy, also left for a round

trip with him.

From what we can gather from Mr. Whitmore, the Company is willing to buy fruit here, but unless the farmers will make a sound proposition to supply her ships weekly from 15,000 to 20,000 bunches of fruit weekly, they are not disposed to enter into a competitive fight and then be left coldly alone, as they were done in the first instance. The Company he says pays for the charter of these boats to go to Pearl Lagoon and load, bot whereas at present they can only get on an average 17,000 bunches from that Port if they could with any certainty get an amount to block theships here on the return certainly they would start in to buy that much and increase as times goes along, provided the government would protect them against the embargoes which they experienced last year. It is now up to the planters to form an association and get in touch with that Company and see what negociations they can make to the best of their interests.

· The suit against the Governor by Ignacio Salgado, relative to the misappropriation of the fundo of the Matina Board of Education is proceeding in the higher Courts in San Jose.

While don Lucas Alvarado has called on the President to investigate certain mesappropriation of Lumber and other materials of the Municipality here by Members of that Board.

In "The Herald" of the 12th inst. we find don Lucas resorting to the pen against the Governor, in consequence of that officers threat to him "that the next time he came to his Office with misdemeanour he would send him to the calaboose," in which letter don Lucas feels that the job of Agent of Police at Cachi, would be more appropriate for Mr. Lara, and reminds him that he Knows to defend himself against all abuses of his sixty two summers.

It will thus be seen that Limon is the worst place in the Republic for intrigues, everyone in every sphere of life, seem to be plotting against the other, with the object of humiliating one and another. When shall we live with honest-minded gentlemen.

Around Limon can be seen Posters, and counter Posters; One Soares seems to have had or believed that he had an agreement with Mr. Fields of Bocas to send labourers down to him at that place; the Company seems to have noticed that the men were leaving here in hundreds and as they need them badly for the Parismina, Santa Clara and Bananito improvement works, they had to put a stop to it by getting Mr. Fields to put a counter order to the one given Soares, saying he does not need any men and Mr. Mullins in his usual generosity to the coloured labourers issues another amendment to the Fields circular, informing the labourers to be undecieved, because the Company does not pay any higher wages in Bocas del Toro than she does here.

One can very well read between the lines, and the only regrettable part of it is, that if Mr. Mullins or Mr. Merril had not closed down the Times so very arbitrarily he would have been able to put a notification in that little journal, which would have done nore good that thousands of his posters, for the people still
